**SUBJECT:** Appointment of the FY10 Grants Advisory Group

**Background**

1. The County Council believes that a strong partnership with non-profit organizations is critical in meeting the county's health and human services and community needs. These partnerships come through competitive contracts and grants and from proposals made directly from the non-profit community to the County Council. The Council has established an FY10 grants process that will require non-profit organizations seeking funds for these purposes to submit a Council grant application form or other acceptable forms by January 30, 2009.
2. To assist the Council in its review of grant proposals from the non-profit community, the Council will appoint a community panel called the Grants Advisory Group to review grant applications.
3. The County Council will designate the Co-Chairs of the Group. The Group will complete its work and report to the Council by April 24, 2009.


