SUBJECT: Amendment to Fiscal Year 2017 Operating Budget
Resolution 18-506, Section G, Fiscal Year 2017 Designation of Entities for
Non-Competitive Contract Award Status – Montgomery County Collaboration
Council for Children, Youth, and Families; Bethesda Cares, Inc.; International
Rescue Committee, Inc.

Background

1. Section 11B-14 (a) (4) of the Montgomery County Code states that “a contract may be awarded without competition if the Chief Administrative Officer makes a written determination that the contract award serves a public purpose and proposed contractor has been identified in a grant or appropriation resolution approved by the Council.” The result of this action is to amend the Fiscal Year (FY) 2017 Designation of Entities for Non-Competitive Contract Award status resolution to include the agency listed below.
2. The Chief Administrative Officer has determined that funding for contracts with these entities serve a public purpose and that such expenses would be in the public interest.
3. The Department of Health and Human Services (DHHS) will fund the contracts with the Providers listed below with existing appropriations for FY 2017.
4. The DHHS will establish contracts with the Montgomery County Collaboration Council for Children, Youth, and Families, Inc., Bethesda Cares, Inc. and the International Rescue Committee for provision of services as stated in the amended FY 2017 Designation of Entities for Non-Competitive Contract Award.

Action


The County Council for Montgomery County, Maryland, approves the following action:

The Council approves an amendment to the Designation of Entities for Non-Competitive Contract Award and thereby amends Resolution 18-506, Section G, FY 2017 Designation of Entities for Non-Competitive Contract Award. The Chief Administrative Officer has recommended this action and stated that amending the contracts for these vendors serves a public purpose and is in the public interest.

The FY 2017 Designation of Entities for Non-Competitive Contract Award Status resolution is amended to:

1. Establish a new contract with the Montgomery County Collaboration Council for Children, Youth, and Families, Inc. in the amount of \$52,500 to read: "Provides for administration and monitoring of funds locally designated for state-certified Youth Services Bureaus (YSB); community-based and non-residential entities providing delinquency prevention; youth suicide prevention; drug and alcohol abuse prevention; and, youth development services to children, youth and their families."
2. Establish a new contract with Bethesda Cares, Inc. in the amount of \$32,143 to read: "Provides for a meal program that provides hot meals for the homeless."
3. Establish a new contract with the Montgomery County Collaboration Council for Children, Youth, and Families, Inc. in the amount of \$50,000 to read: "Provides for administration and monitoring of funds locally designated for pathway to services; Montgomery County's local access mechanism (LAM), a single point of contact for families and providers to access services for children with severe social, emotional and behavioral problems."
4. Establish a new contract with the International Rescue Committee, Inc. in the amount of \$70,000 to read: "Provides for the Central American Minors In-County Resettlement Program (CAM Program) to build government capacity to serve the population, advocate for operational models that enhance identification of parents from Central America who may be eligible to apply to reunite with their children, and develop education/outreach materials to increase awareness of the program."
