SUBJECT: Amendment to Fiscal Year 2018 Operating Budget
Resolution 18-823, Section G, Fiscal Year 2018 Designation of Entities for
Non-Competitive Contract Award Status

Background

1. Section 11B-14 (a) (4) of the Montgomery County Code states that “a contract may be awarded without competition if the Chief Administrative Officer makes a written determination that the contract award serves a public purpose and proposed contractor has been identified in a grant or appropriation resolution approved by the Council.” The result of this action is to amend the Fiscal Year (FY) 2018 Designation of Entities for Non-Competitive Contract Award status resolution to include the agencies listed below.
2. The Chief Administrative Officer has determined that funding for the contracts with these entities serves a public purpose and that such an expense would be in the public interest.
3. The Department of Correction and Rehabilitation (DOCR) and the Department of Health and Human Services (DHHS) will fund the contracts with Providers listed below from existing appropriations for FY18.
4. The Departments will amend contracts with The ARC of Montgomery County, Inc., WorkSource Montgomery, Inc, Interfaith Works, Inc., Manna Food Center, Inc., Center for Adoption Support and Education, Inc., and The Montgomery County Coalition for the Homeless, Inc. for provision of services as stated in the amended FY18 Operating Budget Resolution 18-823, Section G, FY18 Designation of Entities for Non-Competitive Contract Award.

Action

The County Council for Montgomery County, Maryland approves the following resolution:

The Council approves an amendment to the Designation of Entities for Non-Competitive Contract Award and thereby amends Resolution 18-823, Section G, FY18 Designation of Entities for Non-Competitive Contract Award. The Chief Administrative Officer has recommended this action and stated that amending the contracts for these vendors serves a public purpose and is in the public interest.

The FY18 Designation of Entities for Non-Competitive Contract Award Status resolution is amended to reflect:

The DOCR will increase its existing contract with The ARC of Montgomery County, Inc. by \$20,000 for a total of \$55,000 to provide for custodial services to the administrative areas at the Montgomery County Correctional Facility. This amendment is to comply with the County's minimum wage.

The DHHS will establish a new contract with WorkSource Montgomery, Inc., in the amount of \$147,000 to read, "Provides for a pop up job center to provide technical and employability training to qualified job seekers."

The DHHS will amend the purpose of the existing contract with Center for Adoption Support and Education, Inc., from "Provides for the Live, Learn, Lead Academy for youth transitioning from foster care to independence" to "Provides mental health services (individual therapy and group sessions) to older youth transitioning out of the foster care system."


The DHHS will establish a new contract with Interfaith Works, Inc., in the amount of \$52,347 to read, "Provides for the collection and distribution of clothing to low income individuals."

The DHHS will establish a new contract with Manna Food Center, Inc., in the amount of \$30,000 to read, "Provides for a series of events at various faith institutions to build community engagement and to address food security issues within the lens of racial equity."

Additionally, several entries for The Montgomery County Coalition for the Homeless, Inc. were aligned with incorrect dollar amounts. The following table shows the corrected amounts for these contracts.
