Background

- 1. Section 11B-14 (a) (4) of the Montgomery County Code states that "a contract may be awarded without competition if the Chief Administrative Officer makes a written determination that the contract award serves a public purpose and proposed contractor has been identified in a grant or appropriation resolution approved by the Council." The result of this action is to amend the Fiscal Year (FY) 2018 Designation of Entities for Non-Competitive Contract Award status resolution to include the agency listed below.
- 2. The Chief Administrative Officer has determined that funding for the contract with this entity serves a public purpose and that such an expense would be in the public interest.
- 3. The Department of Health and Human Services (DHHS) will fund the contracts with Providers listed below from existing appropriations for FY18.
- 4. The DHHS will establish a new contract with LEAD4LIFE, Inc. and increase the value of and amend the purpose of a contract for the Montgomery County Collaboration Council for Children, Youth, and Families for the provision of services as stated in the amended FY18 Designation of Entities for Non-Competitive Contract Award.

Action

The DHHS will increase an existing contract with the Montgomery County Collaboration Council for Children, Youth, and Families, Inc. by \$25,000, and amend the purpose of the existing contract from "Provide substance abuse prevention activities to promote Opioid Misuse Prevention program" to "Provide current information to Montgomery County residents on medical, legal, and behavioral issues and supports related to opioid and substance abuse."
