Background

- 1. Section 11B-14 (a) (4) of the Montgomery County Code states that "a contract may be awarded without competition if the Chief Administrative Officer makes a written determination that the contract award serves a public purpose and proposed contractor has been identified in a grant or appropriation resolution approved by the Council." The result of this action is to amend the Fiscal Year (FY) 2019 Designation of Entities for Non-Competitive Contract Award status resolution to include the entities listed below.
- 2. The Chief Administrative Officer has determined that funding for the contracts with these entities serves a public purpose and that such an expense would be in the public interest.
- 3. The Department of Health and Human Services will fund the contracts with the entities listed below from existing appropriations for FY 2019.
- 4. The Department of Health and Human Services will amend a contract with the Montgomery County Collaboration Council for Children, Youth, and Families, Inc. for provision of services as stated in the amended FY 2019 Designation of Entities for Non-Competitive Contract Award.
- 5. The Department of Health and Human Services will establish a contract with The National Center for Children and Families, Inc. for the provision of services as stated in the amended FY 2019 Designation of Entities for Non-Competitive Contract Award.

The Council approves an amendment to the Designation of Entities for Non-Competitive Contract Award and thereby amends Resolution 18-1144, Section G, FY 2019 Designation of Entities for Non-Competitive Contract Award. The Chief Administrative Officer has recommended these actions and stated that these actions serve a public purpose and are in the public interest.

The FY 2019 Designation of Entities for Non-Competitive Contract Award Status resolution is amended to:

- 1. Increase an existing contract with the Montgomery County Collaboration Council for Children, Youth, and Families, Inc. in the amount of \$479,876 for a new contract total of \$1,467,376 to read: "Provides the Bridges to the Future program which expands and sustains the existing Child and Adolescent Systems of Care (SOC) by adding a specialized Child Crisis Stabilization Service to the current Crisis Services program to reach, engage, and provide services."
- 2. Establish a contract the National Center for Children and Families, Inc. in the amount of \$49,498 to read: "Develop and carry out a count of youths that can be integrated into the Continuum of Care (COC) annual point in time count.
