SUBJECT: Repeal of Executive Regulation No. 66-89, *Cave-In Team Response*

Background


1. On November 20, 2018, the County Council received Executive Regulation 7-18, *Repeal of Cave-In Team Response*. The proposed regulation would repeal Executive Regulation No. 66-89, First Response for Trench Rescue Incidents, which was originally adopted under Method 2 of Section 2A-15 of the Montgomery County Code.
2. The Council must review the repeal of the regulation under method (2) of Section 2A-15 of the County Code.
3. Under method (2), if the Council does not approve or disapprove a regulation within 60 calendar days after the Council receives the regulation, the regulation automatically takes effect. Code Section 2A-15 allows the Council to extend the deadline for action on a regulation under method (2).
4. The Fire and Rescue Service has issued updated policy guidance in *Incident Response Policy Appendix J, Initial Actions for Technical Rescue Incidents*, Policy Number 24-01, effective January 2, 2019. Therefore, Regulation 66-89 is obsolete.

Action

The County Council for Montgomery County, Maryland approves the following resolution:

Executive Regulation 7-18, *Repeal of Cave-In Team Response*, is approved.

SUMMARY:

Montgomery County Fire and Rescue Commission Executive Regulation No. 66-89 is being repealed and the updated content will be included in the Incident Response Policy No. 24-01. This Regulation was implemented on February 28, 1991 and no longer meets the criteria for modern day Cave-In Team Responses.

BACKGROUND: Standard Operating Procedures provide for safe and efficient fire and rescue operations. This Standard Operating Procedure establishes response criteria, standard dispatch assignments, and procedure to be followed by fire and rescue units and personnel when responding to emergency incidents involving extrication of victims from trench cave-ins or similar accidents. The guidelines are intended to expedite the response of essential apparatus and trained personnel, as well as to assure their safety and the safety of any victim(s) during rescue operations.

[Sec. 1. Purpose.

To establish an SOP to be used by fire and rescue personnel in conjunction with the Cave-In Team on emergency incidents involving extrication from trench cave-ins or similar accidents.

Sec. 2. Applicability.

This regulation applies to all trained members of the Cave-In Team, both career and volunteer, and to other fire, rescue, and emergency medical services personnel who assist them in extrication operations.

Sec. 3. Definitions.

(a) Apparatus. Fire and rescue vehicles, including engines, ladder trucks, rescue squads, extrication units, brush trucks, tank wagons, ambulances and Mobile Intensive Care Units (MICUs), and special units.

(b) Personnel. All on-duty fire, rescue, and emergency medical service personnel, including career, volunteer, and County Merit System employees.

(c) Unit. Specific apparatus staffed by personnel responding to an emergency incident.

Sec. 4. Policy.

(a) Policy Statement. It is the policy of the Fire and Rescue Commission to dispatch the Cave-In Team and Rescue Squad 3 to requests for emergency assistance at the request of the Incident Commander, and on incidents such as the following:

- (1) trench accidents or cave-ins (including incidents when victim is in the trench but not trapped);
- (2) building and construction collapses;
- (3) vehicle into a building with structural collapse; and,

(4) when information received by the supervisor at the Emergency Communications Center (ECC) indicates the possible need for the team's expertise or equipment.

(b) The minimum number of personnel dispatched to a confirmed incident is 12 qualified individuals.

(c) The Cave-In Team is available for dispatch to surrounding jurisdictions upon request.

Sec. 5. Procedure.

(a) Standard Response. The Emergency Communications Center (ECC) will dispatch the following units as a standard response for the above-listed incidents:

- One Engine
- One Truck
- One Rescue Squad
- One Mobile Intensive Care Unit (MICU) and an ambulance if it is closer
- One Command Officer
- One Cave-In Unit and Rescue Squad 3
- Duty EMS Officer
- Montgomery County Police - Code 3

(b) Utilities. ECC will notify all affected utilities (i.e., Washington Gas Light, WSSC, PEPCO, Baltimore Gas and Electric) to facilitate a timely response to assist in stabilization of the scene.

(c) Dispatch. The Montgomery and Fairfax County Cave-In Teams are considered primary response units. The Prince George's County unit will be considered an adjunct when it is closer but this unit will not be dispatched alone. To dispatch the Montgomery County Cave-In Team, ECC will sound the tones to alert Level 3/3 and Level 8/3, in addition to normal applicable response procedures.

(2) The initial response will include on-duty career and volunteer personnel, including two Cave-In Team officers (Trench Sector and Safety Sector).

(3) When a unit on the scene has confirmed an actual entrapment, ECC will sound level 8/3 tones a second time and additional trained personnel may respond.

(d) Rescue Squad 3. Rescue Squad 3 will be dispatched as part of the Cave-In Team response to allow adequate equipment and personnel to implement a planned approach to the incident.

(1) Equipment. Rescue Squad 3 carries the specialized atmospheric monitoring equipment, as well as specialized patient removal equipment for use in confined spaces.

(2) Staffing. In addition to equipment, Rescue Squad 3 will transport properly trained Cave-In Team personnel.

(e) Support. If Rescue Squad 3 is unavailable at the time of dispatch, ECC will dispatch an engine or truck from the Rockville Volunteer Fire Department to provide additional trained personnel. The decision as to which unit is dispatched will be at the discretion of the Cave-In Officer In Charge.

(f) Team SOPs. The Cave-In Team must develop and maintain Standard Operating Procedures for use by team members at the scene of emergency incidents.

Sec. 6. Severability.

If a court of final appeal holds that any part of this regulation is invalid, that ruling does not affect the validity of other parts of the regulation.


