Resolution 18-1144, Section G, Fiscal Year 2019 Designation of Entities for Non-Competitive Contract Award Status; Adult Medical Daycare Providers

Background

- 1. Section 11B-14 (a) (4) of the Montgomery County Code states that "a contract may be awarded without competition if the Chief Administrative Officer makes a written determination that the contract award serves a public purpose and proposed contractor has been identified in a grant or appropriation resolution approved by the Council." The result of this action is to amend the Fiscal Year (FY) 2019 Designation of Entities for Non-Competitive Contract Award status resolution to include the entities listed below.
- 2. The Chief Administrative Officer has determined that funding for the contracts with these entities serves a public purpose and that such an expense would be in the public interest.
- 3. The Department of Health and Human Services will fund the contract with the entities listed below from existing appropriations for FY19. Funding for a payment to support organization that provide Adult Medical Daycare services that accept Medicaid funding was appropriated in the FY19 Operating Budget.
- 4. The Department of Health and Human Services will enter into contracts with the following entities for provision of Adult Medical Daycare services as stated in the amended FY19 Designation of Entities for Non-Competitive Contract Award.
