Background

- 1. Section 11B-14 (a) (4) of the Montgomery County Code states that "a contract may be awarded without competition if the Chief Administrative Officer makes a written determination that the contract award serves a public purpose and proposed contractor has been identified in a grant or appropriation resolution approved by the Council." The result of this action is to amend the Fiscal Year (FY) 2019 Designation of Entities for Non-Competitive Contract Award status resolution to include the entities listed below.
- 2. The Chief Administrative Officer has determined that funding for the contracts with these entities serves a public purpose and that such an expense would be in the public interest.
- 3. The County Council, in Resolution No. 18-1301 approved a \$200,000 Special Appropriation to the FYI9 Operating Budget to enhance security staffing and security preparations for faithbased facilities at higher risk of hate-based crimes.
- 4. The Executive Branch developed the "Faith-based Facilities Security Grants" program, created an online application process and conducted outreach to faith communities across the County.
- 5. The County Executive recommends awarding a total of \$200,000 to 12 individual faith-based organizations.

6. The Office of Emergency Management and Homeland Security will fund the contracts with the entities listed from existing appropriations for FY19. OEMHS will establish one-time contracts with said faith-based entities in amounts totaling \$200,000, to read: "Provides a one-time grant to enhance security staffing and security preparations for faith-based facilities at higher risk of hate-based crimes."

Action

The County Council for Montgomery County, Maryland, approves the following action:

The Council approves an amendment to the Designation of Entities for Non-Competitive Contract Award and thereby amends Resolution 18-1144, Section G, FY19 Designation of Entities for Non-Competitive Contract Award. The Chief Administrative Officer has recommended this action and stated that these actions serve a public purpose and are in the public interest.

The FY19 Designation of Entities for Non-Competitive Contract Award Status resolution is amended to add the following entities for OEMHS to provide one-time grants to enhance security staffing and security preparations for faith-based facilities at higher risk of hate-based crimes.
