Dear Council President Hucker:

The Maryland Department of the Environment (MDE) has completed its review of **Resolution 19-748 (Amendment)** to the 2018-2027 Montgomery County Comprehensive Water Supply and Sewerage Systems Plan. The Amendment was approved on March 2, 2021 by the Montgomery County Council. The Amendment includes six (6) service category change requests. See the summary table of requested service category changes enclosed.

Maryland Department of Planning Findings

Maryland Department of Planning (MDP) has reviewed the amendment and submitted the following comment to MDE for WSP amendment reclassification of 1040 Boswell Lane. MDP found the amendment to appear consistent with the 2002 Potomac Subregion Master Plan (see enclosed comments). MDP also stated that the property is within the Piney Branch Restricted Community Service Area which limits connections, but the Plan also states the following: "Provide community sewer service in the Subregion generally in conformance with Water and Sewer Plan service policies...", and "Amend Piney Branch Restricted Access Policy to allow single home sewer hookups in the Piney Branch subwatershed for existing lots that abut and predate an existing sewer main. This exception is for single houses only and shall not be used to allow for multiple sewer hookups for subdivision/resubdivision of existing properties."

If there are comments or questions regarding MDP's review, MDE encourages the County to contact MDP. See enclosed MDP's comments and contact information.

MDE Findings and Action

MDE notes that of the six category change requests, only one (WSCCR 20-TRV-03A) was approved by the Montgomery County Council. MDE did not review the proposed changes that were denied or deferred by the Montgomery County Council.
