Comprehensive Water Supply and Sewerage Systems Plan Amendments
Proposed Administrative Delegation Action AD 2025-A
Water/Sewer Service Area Category Corrections: 25-TRV-01C & 25-CLO-01C

January 2025

AUTHORITY: Chapter 1, Section V.F.3.a. "Water and Sewer Map Corrections, Revisions, and Informational Updates ", of the Montgomery County Ten-Year Comprehensive Water Supply and Sewerage Systems Plan authorizes the Director of the Department of Environmental Protection (DEP), or his designee, to amend the Plan's service area category maps in order to address documented service and mapping errors. DEP's routine review of properties with access to existing water and sewer mains revealed two properties in need of category map corrections.

WSCCR 25-TRV-01C

BACKGROUND: The property at **13100 Foxden Drive**, designated as sewer category S-6, abuts an existing sewer main along Overlea Drive. The Washington Suburban Sanitary Commission (WSSC Water), Permit Services Section, identified the subject property with an active WSSC sewer service account. WSSC Water service records show that WSSC Water provided a sewer connection to 13100 Foxden Dr. in 1967 at the time the abutting main (no. 1967-2840A) was constructed, but only started an active sewer service account for the property in 1990. This category error became apparent when DEP considered a sewer category change for an adjacent property at 13110 Foxden Dr. (WSCCR 22-TRV-17A, Honrato and Rosvida Nicodemus).

JUSTIFICATION & CORRECTION RECOMMENDATIONS: WSSC Water's confirmation of the existing sewer service account demonstrated that the subject property needs a sewer category correction from S-6 to S-1. Given that a service connection was provided in 1967, the property should have been included in the planned public sewer service envelope shown in the 2002 Potomac Subregion Master Plan.

The approval of category S-3 for 13110 Foxden Dr. (WSCCR 22-TRV-17A) was based on the understanding that 13100 Foxden Dr. had existing public sewer service and is within the planned public sewer service envelope. At that time, M-NCPPC staff and the Planning Board found that the provision of public sewer service to the 13110 Foxden Dr. was consistent with recommendations in the Travilah Planning Area and the Potomac Subregion Master Plan. The County Council therefore granted the category change action under the "consistent with the application of the Potomac peripheral sewer service" administrative policy.

In the case of 25-TRV-01C, a sewer service connection was provided in 1967 prior to the County's administration of the Water and Sewer Plan. An S-6 mapping error has existed since that time. Therefore, DEP staff recommend that the sewer category correction from S-6 to S-1 be granted as consistent with existing policies. No restrictions indicating that public sewer service was provided in error are needed.

WSCCR 25-CLO-01C

BACKGROUND: DEP staff reviewed a preliminary plan for the property at **211 Ednor Road** (no. 120250050) that included a new church sanctuary building proposed to use an onsite septic system. During DEP's review, WSSC Water advised DEP that an existing house on the site was already connected to and served by the public sewerage system from the abutting 21"-diameter main (no. 1965-4095). Due to WSSC Water's confirmation of the existing sewer service accounts, the subject property needs a sewer category correction from S-6 to S-1. DEP has advised the site developer and DPS that the new building should also be served by public sewer, not an onsite septic system.

JUSTIFICATION & CORRECTION RECOMMENDATIONS: Service records show that WSSC Water connected and provided sewer service to the property in 1971, the same year the existing structure was built. The abutting sewer main was constructed in 1968. Furthermore, the Department of Permitting Services located a septic system application from 1971 that was canceled by the applicant, presumably due to the upcoming sewer service connection. Due to WSSC Water's confirmation of the existing sewer service account, the subject property needs a sewer category correction from S-6 to S-1. Public sewer service is consistent with existing plans; in this case, the sewer service connection existed prior to the establishment of the Comprehensive Water and Sewer Plan in 1972. As such, DEP staff therefore recommend that the property should be included in the

planned sewer service envelope and identified as Growth Tier 1 due to the existing sewer service established in 1971. No restrictions indicating that public sewer service was provided in error are needed.

DEP CORRECTION ACTIONS: The water and sewer categories included in the Montgomery County Comprehensive Water Supply and Sewerage Systems Plan are hereby amended as follows:




Figure 1: Sewer Map for 25-TRV-01C showing properties, sewer categories and the planned sewer envelope.




Figure 2: Sewer Map for 25-CLO-01C showing properties, sewer categories and the planned sewer envelope.
