The regular meeting of the Solid Waste Advisory Committee (SWAC) was called to order by the Chair at 5:34 PM on September 7, 2022.

<u>Featured Presentation</u>: Reducing Wasted Food and Increasing Edible Food Recovery in Montgomery County *and* Outreach, Education and Technical Resources Plan re: MD HB 264 (Food residuals diversion mandate)

Speaker: Eileen Kao, Chief, Waste Reduction and Recycling Section, RRMD

Food is too good to waste educational campaign

- In RRMD's efforts to reduce wasted food, the emphasis on education and outreach, raising public awareness of this issue and offering strategies to reduce food waste: "reducing food waste begins with you."
- The information has been translated into three languages (French, Spanish, and Mandarin) and appears in brochures, magnets, a 30-second video, as well as online
- Media used to disseminate the information include websites: DEP/RRMD, Chamber of Commerce; social media, cable TV, streaming radio, movie theatres; ads on buses, bike kiosks; Washington Post inserts, mailings

Edible Food Recovery Program

RRMD is developing a mandatory edible food recovery program, in consultation with DHHS,
 Food Council, and Community Food Rescue

- The Working Group has developed interim recommendations, and are now seeking funding to collect data to estimate how much edible food is available for recovery in the County
- Additional funding and resources will be necessary to establish initiatives and support program

Q & A:

Q: How many FTEs for enforcement in waste reduction section?

A: 4 investigators—3 for commercial, 1 for multi-family. They enforce chapter 48 laws on waste, and recycling regulations, including material bans, e.g. for #6 plastic food service ware and plastic straws.

Q: What data exist to track the quantity of edible food potentially available for recovery? Does the County waste composition study capture this?

A: To estimate total food scraps generated, RRMD is currently using data on food scraps in the municipal waste stream from 2017 waste composition study, and a new waste composition study is in process. However, these studies do not distinguish between edible and non-edible food scraps. Manna collects data on tons of food recovered.

Q: Who in County Government works on distributing recovered food to people in need?

A: It will continue to be a partnership. Within county government the key groups are RRMD, Waste Reduction and Recycling Section and Health and Human Services colleagues.

Q: What impact has the Pandemic had on food waste trends? The waste composition study will reflect these changes. Already know that the majority of food waste during the pandemic was from residential; it had been from commercial sector before the Pandemic.

The new normal includes a lot of teleworking. The next waste composition study will reflect these changes. With the pandemic, it may be harder to recover edible food from commercial establishments.

Outreach, Education and Technical Resources Plan re: MD HB 264 (Food residuals diversion mandate)

RRMD was successful in contacting 1459 of the ~1600 business initially identified as potentially covered by the new diversion mandate. (The remainder may not be in operation now.) Based on survey responses, RRMD estimates that 71 businesses meet the 2 TPW threshold effective January 1, 2023 (generating a minimum of 7384 TPY) and 126 additional businesses meet the 1 TPW threshold effective January 1, 2024 (generating a minimum of 6552 TPY). (To be covered by the mandate, businesses also have to be within 30 miles of an operating food scraps recycling facility; because the RRMD calculations did not include the new Bioenergy Devco AD facility in Jessup, these estimates may understate the number of covered businesses.)

Of the 1,459 food businesses contacted, 76 are currently recycling their food scraps either through composting or as animal feed.

RRMD will provide outreach to spread awareness of the bill's requirements through presentations and mailings, and will offer technical assistance on implementing workplace food scrap recycling programs through its website, webinars, educational videos, site visits, and electronic newsletters.

SWAC Updates

 Robin Barr, Maryland Municipal League rep: Robin is compiling information about the experiences of the incorporated municipalities and cities (which operate collections independently of the County) that have been doing residential collection of food scraps, to provide insights to inform the design of the expansion of County collections of food scraps.
- Field trips Carol will send out polls to schedule field trips to the MRF and Bioenergy Devco AD.
- Adding SWAC Bios on Webpage the committee voted to include short bios of members on the
 website, following the example set by the Climate, Energy and Air Quality Advisory Committee
 (CEAQAC) (except we will not include photos.) [Note: Carol subsequently consulted the members
 who were not in attendance at the end of the meeting when this was discussed, and there were no
 objections.]
