### SWAC report on consolidating single family subdistrict B trash collection under public contracting.

SWAC discussed the revised report draft distributed to SWAC members September 29: *Consolidating Subdistrict B Trash Collection: Lessons Learned from Other communities to Address Hauler Concerns, A First Look.* Following a discussion which resulted in some revisions of the recommendations, SWAC approved the report, which can be found here.

The report focuses primarily on two questions DEP/RRM Division Director Willie Wainer asked SWAC to research regarding the potential consolidation of single family (SF) residential trash collection in upcounty Subdistrict B under public contracting similar to Subdistrict A: (1) what effects would consolidation have on current local trash haulers in Subdistrict B? and (2) what strategies have other communities used to mitigate any potential negative impacts on local haulers during the process of consolidating solid waste services under a public system? In addition, the report provides insights about Subdistrict B residents' level of awareness of solid waste services and opinions about the impacts of consolidation, gleaned from a case study of a recent successful neighborhood campaign to shift to County collections.

The report will now be transmitted to Willie Wainer, who will send it to Jon Monger, DEP Director, and to Keith Levchenko, Senior Legislative Analyst, Environment, Montgomery County Council.
