

**SECOND AMENDMENT TO LICENSE AGREEMENT**

This Amendment to License Agreement ("Amendment"), being made this 26 day of July, 2013, between **MONTGOMERY COUNTY, MARYLAND**, 101 Monroe Street, Rockville, Maryland 20850, a body corporate and politic and a political subdivision of the State of Maryland, (hereinafter designated as the "COUNTY") and the **MENTAL HEALTH ASSOCIATION** of Montgomery County Maryland, Inc. with its principal office located at 1000 Twinbrook Parkway Rockville, Maryland 20852 (hereinafter designated as the "LICENSEE"). (COUNTY and LICENSEE, together, the "PARTIES")

**WHEREAS**, the PARTIES entered into a License Agreement dated August 26, 2009 for use of 2300 square feet of office space located at 3950 Ferrara Drive, Wheaton Maryland; and

**WHEREAS**, the PARTIES desire to amend the License Agreement to reduce the LICENSEE'S area of occupancy for office space.

**NOW THEREFORE**, in consideration of the premises and intending to be legally bound hereby, the PARTIES hereto agree to the following changes and modifications to the Agreement.

1. The PARTIES hereby agree to reduce the LICENSEE'S area of office space by 1400 square feet yielding a total occupied area of 900 square feet.

2. The PARTIES hereby agree to the annual / monthly fee for the reduction of the occupied area as listed in the following table:
