1. Proof of Quorum and Welcome: There being 10 Commissioners present, Chairwoman Nerlinger called the meeting to order at 7:04 p.m.

- 2. Approval of Agenda: Cmr. Anderson moved to approve the July 2, 2025, agenda and Cmr. Holmes seconded. With no objections, the July 2, 2024, agenda was approved by general consent.
- 3. Approval of Minutes: Cmr. Zmuda moved to approve the June 4, 2025, minutes, and Cmr. Holmes seconded. (Cmr. Walker joined the meeting.) Cmr. Seebold moved to amend the minutes and Cmr. Moore seconded; the motion was not carried, with Moore and Seebold in favor; Freeman, Hall, Kraskin, Mezey, Nerlinger, Walker and Zmuda opposed; and Anderson, Fernandez and Holmes abstaining. The June 4, 2025, minutes were approved with Seebold and Moore opposed and Holmes abstaining.
- 4. Community Forum: There were no questions from the audience during the open forum.
- 5. Chairwoman's Report: Chairwoman Nerlinger did not have a report.
- 6. Submission of disputes for Commission consideration: Jurisdiction Ms. Fabayo presented the following cases to the Commission:

2024-082, Brian Campbell v. Hampshire Hamlet Homeowners Association – Cmr. Walker moved to deny jurisdiction of the case and Cmr. Zmuda seconded the motion. The motion was carried by the Commission, with Nerlinger and Moore opposed and none abstaining.

2025-045, Bram Van Loon, et al. v. New Mark Commons Homes Association – Cmr. Walker moved to accept jurisdiction of the case and Cmr. Mezey seconded the motion. The motion was carried by the Commission, by general consent, with none opposed and Anderson abstaining. Cmrs. Mezey and Walker were appointed to the hearing panel.

2025-048, Maybelle Howze v. Fairways South at Leisure World, A Condominium – Cmr. Walker moved to deny jurisdiction of the case and Cmr. Fernandez seconded the motion. The motion was carried by the Commission by general consent with Cmrs. Mezey and Moore opposed and Cmrs. Anderson and Freeman abstaining.

2025-050, William Wilkinson v. Grosvenor Park IV Condominium – Cmr. Walker moved to accept jurisdiction of the case and consolidate it with case 2025-034 and Cmr. Moore seconded the motion. The motion was carried by the Commission, by general consent, with Cmrs. Seebold opposed and Nerlinger abstaining. Cmrs. Anderson and Fernandez were appointed to the hearing panel for a hearing on August 7th.

2025-058, Angelica Bautista v. North Creek Place Condominium – Cmr. Walker moved to deny jurisdiction of the case and Cmr. Moore seconded the motion. The motion was carried by the Commission, by unanimous consent, with none opposed or abstaining.

2025-059, Steven Yegher v. CUO of Mutual 14 Condominium of Rossmoor – Cmr. Hall moved to deny jurisdiction of the case and Cmr. Walker seconded the motion. The motion was carried by the Commission, by general consent, with Anderson and Freeman abstaining.
