SUBJECT: Report Required under Section 29-6(h) of the Montgomery County Code Related

to Rental Housing Inspections for the Period July 1, 2024, through June 30, 2025

Summary

As required in Section 29-6(h) of the Montgomery County Code, the Director of the Department of Housing and Community Affairs (DHCA) must submit an annual "Troubled Property Report" on multifamily rental housing inspections conducted each Fiscal Year (FY) (July 1 through June 30) to the County Executive and County Council. This report summarizes the FY25 inspection findings and Code Enforcement outcomes for multifamily rental apartment properties. This report also contains data and information on the following topics:

- 1) A list of multifamily rental properties inspected during FY25, inspection results, and a "Troubled Property" list. (Attachment 1)
- 2) A list of multifamily properties that did not submit corrective action plans and maintenance reports, remaining troubled (Attachment 2)
- 3) A list of multifamily properties to be inspected in FY26. (Attachment 3)
- 4) Housing code violation citation data for FY25.
- 5) Montgomery County 3-1-1 (MC311) call center service request data on complainant preferred languages in languages other than English or Spanish.

Key Findings

Key findings from DHCA's 2025 Troubled Properties Report include:

- The total number of units in Troubled Properties decreased by 69%: The total number of units on the list declined from 7,269 in FY24 to 2,264 in FY25. There are a total of 67 Troubled Properties in FY25, a decrease from 93 in FY24. Of the Troubled Properties designated in FY24, 38 properties comprising 1,814 units remain designated as Troubled because they did not submit corrective action plans and/or maintenance reports or have not yet abated violations previously identified by DHCA inspectors.
- The total number of units in At-Risk Properties decreased by 57%: The total number of units on the list declined from 6,375 in FY24 to 2,740 in FY25. There are a total of 55 At-Risk Properties in FY25, a decrease from 76 in FY24. Of the At-Risk Properties designated in FY24, 18 properties comprising 923 units remain designated as At-Risk because they have not yet abated violations previously identified by DHCA inspectors.
- The rate of housing code citations issued for failure to comply dropped by more than half: Among all inspections (both complaint-based and mandated), DHCA issued 2,059 Notices of Violation (NOVs) to 972 multifamily rental properties. A total of 69 multifamily rental properties failed to make the repairs required by these notices, resulting in 364 citations. In comparison, in FY24, DHCA issued 1,767 NOVs, resulting in 754 citations for 90 multifamily rental properties that failed to comply.
- Property owners increased compliance efforts following passage of rent stabilization limitations on rent increases for Troubled and At-Risk properties: Following the implementation of the Rent Stabilization law and its provisions that limit rent increases at rent stabilized properties that have a Troubled or At-Risk designation, property owners and management have increased their efforts to obtain a Compliant rating by seeking assistance from contractors and specialists to assist with preparing for inspections, correcting violations identified during initial inspections, and developing Corrective Action Plans and Tenant Work Request reports. Additionally, properties that are designated as Troubled or At-Risk are resolving identified violations much sooner.

Background

The DHCA Code Enforcement Section is committed to carrying out its mission to correct problems that contribute to the physical decline of residential properties and neighborhoods. In doing so, through inspection processes, DHCA ensures that existing housing is safe and habitable for all Montgomery County residents. Annually, the Code Enforcement Section conducts an average of over 37,000 inspections and investigates over 10,000 MC311 service request complaints for residential single-family and multifamily dwellings, commercial building exteriors, and vacant lots. To further enhance the County's ability to ensure the proper maintenance of multifamily rental properties and units by owners and property management companies, the County passed Executive Regulation, 5-17 "Troubled Properties" and associated

Bill 19-15 "Licensing of Rental Housing-Landlord-Tenant Obligations" in 2017. In part, these regulations require DHCA to inspect all the nearly 700 multifamily properties within DHCA's jurisdiction.

After a multifamily property is inspected, DCHA calculates two numerical scores: the Total Number of Violations score (TV) and the Severity of Violations (SV) score. As determined by the property's inspection scores, properties are identified as Troubled, At-Risk, or Compliant. DHCA then develops a "Troubled Property" prioritized inspection action plan. The goal is to inspect Troubled and At-Risk properties more frequently to ensure that violations are adequately corrected and that steps are taken to improve their inspection scores. For properties designated as Troubled, 100% of the units are inspected annually. Additionally, Troubled properties are required to submit a Corrective Action Plan that identifies their plan to correct existing violations and what steps they will take to ensure new violations do not occur in the future. Troubled Properties are also required to submit quarterly reports of tenant work requests so that DHCA can determine if work requests are being responded to adequately and in a timely fashion. Properties designated as At-Risk are inspected at least every two years, or more often upon request, and a minimum of 25% of the units in these properties are inspected. The goal is to ensure that At-Risk properties do not fall into Troubled status by way of more frequent inspections. For properties designated as Compliant, 25% of the units in the property are inspected every three years.

During FY24 and continuing into FY25, DHCA identified several technology-related issues that continued to create challenges related to scheduling multifamily rental housing inspections. The Department has been actively working to correct these issues to ensure that all scheduled inspections are completed in a timely fashion. First, at the beginning of FY24, DHCA discovered that the inspections of several small, Troubled properties were not scheduled and therefore not conducted because the Code Enforcement database did not effectively generate inspection schedules for properties with expired rental licenses. These properties were identified in the FY24 report and were inspected early in FY25. Second, DHCA found that the housing code inspection operating application and the mobile inspection application periodically had difficulty processing significant volumes of information when several simultaneous inspections were conducted at large multifamily properties. DHCA's Information Technology (IT) team, with the assistance of a contractor that specializes in iOS applications, has made major progress in implementing remedies to address these concerns. They have nearly completed the process of revamping the mobile inspection application to develop a much more user-friendly and stable operating application. Additionally, they have completed major modifications to the programming of the operating application, including improving the ability to process inspection data, automating the analysis process used to determine property scores, adding the ability to capture historical data, and automating the process to develop inspection schedules. They also continue to make progress with respect to enhancing the ability to generate reports.

Lastly, FY25 is DHCA's first year conducting property inspections since the passing of the County's Rent Stabilization law that went into effect in July 2024. In part, this law limits the ability of regulated properties designated as Troubled or At-Risk to raise rents during the time that they hold those designations. Since the passing of the Rent Stabilization law, DHCA has found that properties designated as Troubled and At-Risk have significantly increased their

efforts to obtain a Compliant rating. Many properties have sought the assistance of contractors and specialists to assist with preparing for inspections, correcting violations identified during initial inspections, and developing Corrective Action Plans and Tenant Work Request reports. The efforts of these properties to respond to the requirements of the Rent Stabilization law, combined with the increased Code Enforcement efforts, have resulted in a significantly smaller number of properties collectively identified as Troubled and At-Risk in FY25. Further, in FY25, the Department observed that properties designated as Troubled or At-Risk are resolving identified violations much quicker, resulting in safer properties for County residents.

In FY25, there were 29 properties identified as Troubled based on mandated inspections comprising 450 units, and 37 properties identified as At-Risk comprising 1,817 units. (see Table 1, Chart 1, and Chart 2 below). In addition to the 29 properties identified as Troubled based on inspections, 38 properties containing 1,814 units remain designated as Troubled because they did not submit corrective action plans and/or maintenance reports or have not yet abated violations previously identified by DHCA inspectors. Additionally, of the At-Risk Properties designated in FY24, 18 properties comprising 923 units remain designated as At-Risk because they have not yet abated violations previously identified by DHCA inspectors. Thus, including both newly designated and properties with carryover designations, there are a total of 67 Troubled Properties with a total of 2,264 units and 55 At-Risk Properties with a total of 2,740 units in FY25.

In comparison, in FY24 there were a total of 93 Troubled Properties (54 newly-designated and 39 carryover) comprising 7,269 total units (3,062 newly-designated and 4,207 carryover) and 76 At-Risk Properties (34 newly-designated and 42 carryover) comprising 6,375 units (2,484 newly-designated and 3,891 carryover).

Properties Inspected in FY25 and Inspection Results

During FY25, the Code Enforcement Section conducted multifamily mandated inspections and completed 15,436 interior unit inspections at 350 properties. The tables and charts below provide a breakdown of multifamily rental property inspection results for FY25.

Charts 1 and 2 below show the percentage of properties and units that are currently designated in the Troubled, At-Risk, and Compliant categories relative to the total number of properties and

units in Montgomery County. (Note that some of the properties in the Compliant and At-Risk categories were not scheduled for inspection in FY25.)

Chart 3 below shows the total number of Montgomery County rental units in properties designated At-Risk or Troubled, comparing FY24 and FY25.

Chart 1: Percent of Multifamily Rental Properties Designated as Troubled, At-Risk, or Compliant in FY25




Chart 2: Percent of Multifamily Rental Units Designated as Troubled, At-Risk, or Compliant in FY25





Chart 3: Number of Montgomery County Rental Units in Properties Designated At-Risk or Troubled, FY24 vs. FY 25



Properties Scheduled to be Inspected in FY26

In FY26, DHCA's Code Enforcement Section will inspect 12,207 units in 340 properties, as detailed in Table 2 below and in Attachment 3. Table 2 below identifies the categories of multifamily units and properties that DHCA's Code Enforcement Section will inspect in FY26 and includes 100% of properties identified as Troubled in FY25, in addition to the At-Risk and Compliant properties scheduled for inspection in FY26.

^{*} In FY25, there are 38 additional properties that were categorized as Troubled in FY24 and remain Troubled due to noncompliance with the FY24 designation (see attachment 2). In total, during FY25, there are 55 At-Risk properties, which include the 18 designated in the table above and an additional 37 that were designated in Table 1.

Number of Citations Issued in FY25

The primary goal of DHCA's housing code inspection program is to ensure compliance with the County's housing laws and safety standards. To that end, DHCA achieves a high level of compliance from the owners and managers of multifamily rental properties without the need to issue citations to the landlords. Inspectors and landlords alike recognize that having the landlord correct a deficiency for the benefit of the tenant is the most desirable outcome. Consequently, as in previous years, there is generally a low number of citations issued, resulting in court cases, demonstrating that the ongoing work of the Housing Code Enforcement Section achieves a high level of compliance.

A Notice of Violation (NOV) is issued to a landlord when a code violation is identified by a Code Enforcement Inspector during a complaint-based or a scheduled, mandated inspection. A NOV may include multiple code violations on the notice. During FY25, DHCA issued 2,059 NOVs for 19,696 Code violations to 443 unique multifamily rental properties. Sixty-nine multifamily rental properties failed to make the repairs required by these NOVs, resulting in 364 citations. Fortunately, most landlords made the required corrections, and as a result, many citations were dismissed prior to the court hearing. Comparatively, in FY23, DHCA issued 2,896 NOVs for 30,998 Code violations to 388 unique multifamily properties, and in FY24, DHCA issued 1,767 NOVs for 34,486 Code violations to 335 unique multifamily properties. In FY23, 39 properties failed to adequately make repairs associated with NOVs, resulting in 2,783 citations issued. In FY24, 39 properties failed to adequately make repairs associated with NOVs, resulting in 754 citations issued. This data demonstrates that Code Enforcement efforts are increasingly effective in compelling landlord compliance.

Court hearings for citations are backlogged and generally occur up to eight months after issuance. Some landlords wait for hearings before making required repairs, so the delay results in some repairs not being made for several months. Also, judges often significantly reduce fines during hearings if landlords have made the required repairs prior to the hearing. For example, in FY24, DHCA attempted to recover over \$1.5 million in unpaid fines through the District Court, but only collected \$100,375. For these reasons, fines collected from citations have been consistently low since the beginning of the COVID-19 pandemic and continue to remain negligible.

DHCA and the Office of the County Attorney continue to explore options to improve housing code compliance by landlords who have a history of not remedying NOVs and citations within required deadlines. The two departments collaborated with the Office of Consumer Protection (OCP), the County Executive, and the County Council to pass Bill 6-25, which went into effect in April 2025. Bill 6-25 amended Chapter 11 of the Montgomery County Consumer Protection Code to expand the definition of a "person" to include a landlord; clarify that consumer goods and services include rental housing; remove the exemption for defective tenancies or complaints

¹ In previous reports, the figures associated with the number of properties that received NOVs and code violations did not reflect the number of unique properties, but rather the total number of properties that were issued NOVs and code violations, considering that a property may have been issued unique NOVs and code violations more than once. In this report, the number reflects the total number of unique properties that were issued NOVs for code violations by the Department.

related to landlord-tenant matters; allow OCP to write citations based on Chapter 29 (Landlord-Tenant Relations) of the County Code because violations of Chapter 29 would be considered "deceptive, unfair, or unconscionable trade practices"; and provide OCP and OCA with the ability to sue landlords who have been cited for deceptive trade practices under Chapters 11 and 29 in Circuit Court to "seek damages, restitution, the posting of a bond, or any available legal or equitable relief, including declaratory, preliminary, temporary, or permanent relief," in addition to paying the County attorney's fees if it prevails. DHCA, OCP, and OCA have completed Standard Operating Procedures for how the three departments will collaborate on implementing these amendments.

311 Calls Concerning Rental Housing Complaints by Language of the Caller

In addition to conducting the inspections required under Section 29-22 of the Montgomery County Code, the Code Enforcement Section responds to individual tenant complaints on a routine basis. Most of these complaints are received through the County's 311 Call Center. A few complaints are received through in-person visits to DHCA's office. Over the course of FY25, the Code Enforcement Section responded to 2,057 complaints at multifamily rental properties. An additional 4,175 housing-related cases were received and followed up on at non-multifamily properties in the County and rental and complaint inspections within the City of Takoma Park. DHCA has a memorandum of understanding with the City of Takoma Park, whereby DHCA conducts inspections within this jurisdiction for a fee. Regardless of jurisdiction or origination, these tenant-originated complaints are referred to as Service Requests.
