- **1. Proof of Quorum and Welcome:** There being a quorum of Commissioners present, Chairwoman Nerlinger called the meeting to order at 7:03 p.m.
- **2. Approval of Agenda:** Cmr. Hayes moved to approve the April 5, 2025, agenda and Cmr. Mezey seconded. With no objections, the April 2, 2025, agenda was approved by acclamation, with none opposed.
