Minutes of the Monthly Meeting – Final Approved with Amendment January 7, 2026, CS

**1. Proof of Quorum and Welcome:** A Quorum was present. Chair Nerlinger called the meeting to order at 7:04 p.m.

**2. Approval of Agenda:** The Agenda was approved unanimously.

**MOTION** to accept jurisdiction of the case was made by Commr. Zmuda and seconded by Commr. Walker. The Motion unanimously carried---**Jurisdiction accepted.** Commrs. Seebold and Zmuda volunteered to serve on the Hearing Panel.

### **6. B. 1. Case 2025-070, Ronald A. Burrows v Derwood Station HOA**

**MOTION** to accept jurisdiction of the case was made by Commr. Holmes and seconded by Commr. Mezey. Commr. Nerlinger recused. The Motion carried---**Jurisdiction accepted.** Comms. Mezey and Morton volunteered to serve on the Hearing Panel.

**MOTION** to transfer the Hearing of the case to the Office of Zoning & Administrative Hearings (OZAH) was made by Commr. Holmes and seconded by Commr. Walker. Commr. Anderson recused. The Motion carried---**Hearing of the case is transferred to OZAH.** During debate, Commr. Walker stated for the record that she recommended that the three newly appointed Commissioners serve on the Hearing Panel. Commr. Potts volunteered to serve on the Hearing Panel.
