DEMOCRACY BLVD. PROJECT PHASE I & II

PURPOSE

This newsletter is to inform you of the upcoming road repair for Democracy Boulevard, from I-270 to Seven Locks Road. The repair will take place in two phases. Phase I will focus on Concrete Repairs consisting of sidewalk, curb & gutter repairs and is set to begin on June 30, 2025. This will be followed by Phase 2, which involves Nighttime Mill & Overlay Work of roadway resurfacing, starting on July 21, 2025. We anticipate that all work will be completed within approximately 70 days. Please see the reverse side of this newsletter for the project map.

IMPACTS

Parking signs may be posted in advance. There will be lane shifts and lane closures. We will do our best to keep impact to traffic at a minimum. Please walk & drive carefully through the work zone and obey all posted signage. We thank you for your cooperation and patience as we work to improve the County infrastructure for residents and users.


