Overview

Montgomery County Department of Transportation, Ride On Transit Services is proposing to discontinue a stop at Connelly School of the Holy Child. As part of the county's commitment to receive comments from the public, a public forum is being conducted on the proposed changes. This process allows Montgomery County Department of Transportation, MCDOT, to gather the most information possible regarding the proposed service changes which will provide the best opportunity for success.

The revised routing will eliminate the stop at the Connelly School of the Holy Child and creates a loop routing between Seven Locks Road, River Road and Bradley Blvd. All other routing remains unchanged.

It is important to note, staff evaluates new service over a year to 18-month time span to gauge the effectiveness of the service. The regular Ride On fare is \$2.00. Seniors ride free between 9:30 am – 3 pm Monday through Friday and Saturday hours include 8:30 am – 4pm. Half fare at all other times. Kids Ride Free all day.
