- 3. <u>INCOME</u>: Please submit proof of total income for all adult members of your household with this application. For minors (Ages 0-18) provide proof of birth dates. For adult members in the household proof of income can be one or more of the following: a copy of all household income tax returns, Social Security checks, Social Security award letters, pension letters, annuity statements, SSI, job earnings, bank statements to show interest, dividend payments, or IRA distributions, etc. PROOF OF ALL INCOME FOR ALL MEMBERS OF THE HOUSEHOLD MUST BE SUBMITTED WITH THIS FORM.
