Mrs. Khozeimeh thanked the redistricting team, in particular Louise Warner for her long working hours and dedication to redistricting mapping.

Ms. Merino-Dean stated that Sheldon Fishman requested to address the Board in advance.

**[2:24]** Sheldon Fishman acknowledged and appreciated how easy it is to register to vote in the state of Maryland. He also thanked the Board for the improvements it has made to the process up until this point. Mr. Fishman asked how a voter can go online and see who is running in the County Council district in which they live. He noted that current information on the Board website does not reflect the current County Council districts.

Ms. McLaughlin stated that the information on the website is not current and does not yet reflect the potential changes of redistricting. She noted that once the final changes have been made, the website

would be updated.

Ms. Ross responded that the website to which Mr. Fishman was referring may not have been in direct relation to what the Board of Elections has on its website. She noted that the information Mr. Fishman was suggesting can be found on the County Council redistricting commission website and said that she would look more into linking this information on the [Board of Elections] website to make it easier for voters to access.
