# [12:50] Additions to the Agenda

The staff added to the agenda possible changes in the Early Voting sites.

Regarding those changes, Ms. Rzeszut announced that the Board can still use the Sandy Spring Fire Station for an Early voting site. However, there is a problem with the Activity Center at Bohrer Park



since camps will be in session at the gyms, and staff recommends using the gymnasium in the nearby Gaithersburg High School.

Also, Early Voting cannot be held at the Great Hall at the Silver Spring Civic Building, since weddings, parties, and conferences have been booked there for parts of the Early Voting period. The Board and staff discussed alternatives, including using rooms on the second floor of the building (which total about 1800 square feet, compared with 4,000 square feet in the Great Hall). Mr. Naiman suggested that staff explain the Early Voting issues on the website, to give the public advance notice and give them a chance to comment on the proposed changes at the meeting on April 18. He also noted that the Silver Spring Civic Center has repeatedly had the highest total of Early Voting votes in the County and is one of the highest in the State.
