Mr. Naimon noted that 05-06 (White Oak) had a peak wait time of more than an hour in 2018 and would like to do what we can to minimize lines to vote at that location, particularly for the General Election.

Mr. Karpinski mentioned that there would be a preliminary meeting in May to discuss the staffing levels at various polling places.

[5:21] Ms. Rzeszut illustrated the original break-up in 2012 with School Board and Legislative line make-ups to justify the changes for moving both 04-37 and 04-40 into 04-07.

[10:00] The staff and board discussed location changes for 04-27.

[23:47] Mr. Naimon moved that the following precincts, 04-07, 04-27, 04-37, 04-43, 04-40 vote at Twinbrook Elementary School. The motion was seconded by Ms. Dillon and passed unanimously.

[26:25] Mr. Naimon moved to approve precinct 05-06 to vote at Jackson Road Elementary School for the Primary Election including the change for precinct 05-05 to Springbrook High School, with the understanding that the Board will look at further options for the General Election, and that the Board will hear in May about addressing wait times in 05-06 and the other precincts. The motion was seconded by Dr. Barnes and passed unanimously.

[27:14] Future Meetings

Mrs. Khozeimeh noted that the Council Budget Meeting would be held on Monday at 1:30. Khozeimeh also thanked the staff for their hard work on this difficult task.

Ms. McLaughlin requested that due to a conflict, the May 16th Board meeting be rescheduled to May 23rd.
