### **2026 Election Day Voting: No Electioneering**

## >Election Law§10–101 (a) (3) (iii)

- 1. Subject to subsubparagraph 2 of this subparagraph, electioneering shall be allowed on the premises of the public building up to the electioneering boundary established under § 16–206(b) of this article.
- 2. Campaign signs shall be allowed on the premises of the public building, at a minimum, from:
  - A. 5 p.m. the day immediately preceding election day until 8 a.m. on the day immediately following election day; and
  - B. 5 p.m. the day before an early voting period begins under § 10–301.1 of this title until 8 a.m. the day after the early voting period ends.

## ➤ Election Law§16–206

- (a) A person may not:
  - (10) canvass, electioneer, or post any campaign material in the polling place or beyond a line established by signs posted in accordance with subsection (b) of this section.

(b)

- (1) At each polling place, one election judge from each principal political party shall be designated by the local board and, acting jointly, shall post signs delineating a line around the entrance and exit of the building that are closest to that part of the building in which voting occurs.
- **(2)**
- (i) Except as provided in subparagraph (ii) of this paragraph, the line shall be located as near as practicable to 100 feet from the entrance and exit and shall be established after consideration of the configuration of the entrance and the effect of placement on public safety and the flow of pedestrian and vehicular traffic.
- (ii) In Montgomery County, on approval of the local board, the line may be located at any point between 25 feet and 100 feet from the entrance and exit.
- (3) The signs shall contain the words "No Electioneering Beyond this Point".
- (c) A person who violates this section is guilty of a misdemeanor and is subject to a fine of not less than \$50 nor more than \$500 or imprisonment for not more than 60 days or both.

## 2026 Election Day Voting: No Electioneering

No electioneering zone around drop boxes (required at 25 ft) will differ during early voting and on election day as drop boxes at these locations will be integrated into early voting centers' or election day polling place no electioneering zones.

COMAR 33.11.01.04 D (3)

If the ballot box is placed within the electioneering boundary of a polling place, the line for the ballot box shall be the electioneering boundary of the polling place.







05-02 - GREENCASTLE ELEMENTARY SCHOOL – NO ELECTIONEERING ZONE (RENOVATED ENTRANCE)




