**ELIGIBILITY REQUIREMENTS TO RECEIVE THE PROPERTY TAX CREDIT – DISABLED VETERANS**

- The disabled veteran's property must be their principal residence, and must not be occupied by more than 2 families.
- The disabled veteran must have been discharged under honorable conditions from active service in the U.S. Armed Forces as defined in 38 U.S.C. Section 101.
- The disabled veteran must have been declared to have a permanent service-connected disability of at least 50%, that is reasonably certain to continue for the life of the disabled veteran, and was not caused or incurred by misconduct of the disabled veteran, or a 100% service-connected disability for a non-permanent disability.
- The federal adjusted gross income of the disabled veteran for the immediately preceding taxable year must not exceed \$100,000.
- The disabled veteran must submit this application on or before April 1 before the tax year that the disabled veteran seeks to receive the property tax credit. The disabled veteran must include with the application, a copy of the disabled veterans discharge from active-duty military service, and certification of the disabled veteran's disability from the U.S. Department of Veterans Affairs.
