The Commission on Veterans Affairs is pleased to present a summary of its activities for the past year. Under your leadership and with your support, the Commission is mandated to research, assemble, analyze and disseminate information that will assist in meeting the needs of County Veterans and their families.

We continue to support coordination and collaboration among federal, state and County agencies, and non-profits that serve Veterans so that our community works together to provide all of the many services and resources possible to Veterans and their families. We work to build an inclusive community and promote social connectiveness for our Veterans and their families. We encourage Veterans and their families to contact ServingTogether as a starting point for any needed services at 301-738-7176 and www.everymind.org/servingtogether/. For benefits and claims assistance, please contact Christina Williams of the MD Department of Veterans Affairs at 301-987-8412. We commend the County for having the goal of functional zero homelessness amongst Veterans in the County. However, at this time, there are 50 homeless Veterans in the County and we will be working to have the County obtain more permanent housing vouchers for our Veterans.

In collaboration with the Commission, Montgomery Parks, part of the Maryland National Capital Park and Planning Commission, constructed and maintains two accessible launches for non-motorized boats at Seneca Landing Special Park. Because the general public and Veterans have benefitted so much from their installation, Parks plans to add accessible launches where they have boat/kayak launches. We thank the Montgomery County Department of Transportation for a Ride on Bus Wrap honoring Operation Green Light and Veterans Day and bus cards for 385 buses with contact information for ServingTogether and the Commission. The Commission's two top priorities for FY'27 include Communication and Outreach Planning to Promote Programs and Services that Benefit Veterans and Their Families and to Recognize the Service of Veterans. This includes working with the District Court to establish a Veterans Treatment Court.

We wish to recognize and give our personal thanks to all Commissioners, the many community members, and the agency staff who participate in our meetings for their commitment and dedication to Veterans and their families We would like to acknowledge DHHS Director Dr. James Bridgers for his role in meeting with the Boards, Commissions and Committees to keep us informed of important health and human services issues, Betsy Tolbert Luecking, Community Outreach Manager, and Carly Clem, Program Specialist II, for their support in providing the Commission with the resources needed to carry out our mission. This report is the result of our combined efforts.

It has been a pleasure to work with you and members of the Commission during our term of service. We are confident that you will continue to support the Commission's efforts to enhance the lives of our Veterans. Our meetings are open to the public, and we invite you to join us for any meeting. Please read the <u>timeline and major accomplishments of the Commission</u> since it was established.



ABOUT THE COMMISSION

HISTORY

The Montgomery County Commission on Veterans Affairs was established by County legislation in 2008 with the goal of the Commission to provide advice to the County Executive and County Council on the status of programs and services related to the needs of Veterans. Veterans have made an important contribution to the community by their service in the Armed and Uniformed Services of this Nation, and Montgomery County is committed to showing its commitment and support for all veterans and their families.

MISSION

The Commission will research, assemble, analyze and disseminate information and educational materials relating to activities and programs that will assist in meeting the needs of veterans and their families; institute and conduct educational and other programs, meetings, and conferences to promote the rights and opportunities for veterans; advise the Executive and the Council on the status of programs and services in the State and County related to the needs of veterans and their families; and assist in planning appropriate public acknowledgement of the contributions made by veterans, and assist in planning commemoration activities recognizing the contributions made by veterans. The Commission does not provide services. The Commission maintains a Veterans Directory online that includes all the services offered by the federal state and local government and non-profit agencies www.montgomerycountymd.gov/vnd.

MEMBERSHIP

The Commission on People with Disabilities is composed of 16 voting members who serve in a volunteer capacity. Members are appointed by the County Executive and confirmed by the County Council.

The Commission includes:

- ▶ 9 Veterans,
- ▶ 4 members representing the general public, and
- 3 ex-officio members representing the Director of the Department of Health and Human Services; the County Executive; and the Director of Montgomery College.

The Executive must invite a representative of the County's Congressional delegation who is either a member of the delegation or an individual designated to represent the delegation to be a non-voting member of the Commission. The Executive must also appoint a member from the Commission on People with Disabilities to be a non-voting member of the Commission.



TOP POLICY PRIORITIES FOR FY27

Commission on Veterans Affairs

Meeting with HHS Committee of County Council on Priorities for FY27 Michael Wilson, Chair - Chris Thomas, Vice-Chair October 22, 2025

1) Communication and Outreach Planning to Promote Programs and Services that Benefit Veterans and Their Families

Greater Community Outreach and Education on Veteran Issues - The Commission will develop a plan to increase communication with the public and other organizations that serve Veterans. There is a need for more face-to-face and real-time and non-real-time virtual interaction. Commission members will be encouraged to visit veteran service organizations such as local American Legions (AL), Veterans of Foreign Wars (VFW), AMVETS, Disabled American Veterans, Vietnam Veterans of America, Paralyzed Veterans to share information about the work of the Commission and learn from these organizations about what they believe are unmet needs of Veterans and their families.

Provide Support to the Office of Problem-Solving Courts as they Plan and Implement a Veterans Treatment Court in Montgomery County - The Commission is working in collaboration with the Maryland Military Coalition and the Military Officers Association of America (MOAA) to provide support as requested from Judge Koch and the Office of Problem-Solving Courts to establish a Veterans Treatment Court in Montgomery County. We would greatly appreciate the Council's support for this important initiative.

Permanent Supportive Housing Vouchers for Homeless Veterans Including those with Families - We recommend the County make greater investment in permanent supportive housing which includes case management for homeless Veterans. This includes seeking additional HUD-VASH vouchers from the federal government. HUD-VASH is a collaborative program which pairs HUD's Housing Choice Voucher (HCV) rental assistance with VA case management and supportive services for homeless Veterans. Veterans who have case management along with a voucher have greater success with permanent housing in the community. At this time, there are an estimated 50 homeless Veterans in the county and too often they are placed in emergency shelters. We recommend less investment in emergency shelter response. We ask the Council to continue needed funding for vouchers for Veterans not eligible for Veterans Administration benefits including HUD-VASH vouchers.

2) Commission was Established to Recognize the Service of Veterans

Planning for Operation Green Light / Veterans Day and Memorial Day - Commission will plan and participate in Veterans Day and Memorial Day recognition events.

Websites and Digital Displays to Honor Veterans - On www.montgomerycountymd.gov/veterans there are websites created by staff honoring County Veterans for Hometown Fallen Heroes going back to World War I, Vietnam Era Veterans, Women Veterans, Recognition for Veterans for Black History Month, and Thank You to County Veterans for Veterans Day.

Speakers Bureau - Commission will develop a speaker's bureau to volunteer to speak at schools about Veteran issues and the meaning of Veterans Day and Memorial Day. The Commission publishes an annual report that includes information on the Commission's work and includes extensive data on Veterans. Go to www.montgomerycountymd.gov/cva.

Lastly, it is critical for Boards, Committees and Commissions (BCC) to have commissioners appointed in a timely manner so that they can be most effective and also respect the volunteer service of community members who serve. We ask that the County ensure proper staffing for the County Executive's Office for timely recruitment and appointment of BCC members.

LETTER OF SUPPORT TO COUNTY EXECUTIVE FOR ESTABLISHING A VETERANS TREATMENT COURT

Dear County Executive Elrich and Council President Stewart:

The Montgomery County Commission on Veterans Affairs writes to express its strong support for the establishment of a Veterans Treatment Court (VTC).

A VTC is a court supervised, comprehensive and voluntary treatment program for justice system-involved Veterans charged with (primarily) non-violent misdemeanors in a Maryland District Court. U.S. military veterans – whether eligible for VA benefits or not – are eligible for a VTC. The Commission has met and discussed this issue and received briefings on it in recent months. Veterans and veterans groups are of one mind in supporting it.

Since 2008, over 1000 VTCs have been created across the nation. Why? Research has shown that justice-involved veterans who complete the program have a lower recidivism rate than Veterans who go before traditional or other problem-solving courts. All of our neighboring Maryland Counties have either their own VTC – Anne Arundel, Frederick / Washington, and Prince George's – or are participating in the (Central) Maryland Regional VTC: Carroll and Howard Counties. With over 36,000 veterans, Montgomery County has the fourth largest veterans population in the State, which suggests that the smaller Carroll, Howard, Frederick / Washington Counties will have a significantly smaller demographic of veteran offenders.

The need, resources and judicial engagement are available to support this important project. First, the need. Veteranoffender caseloads in our County are comparable to neighboring jurisdictions. The Office of Problem Solving Courts,
Annapolis, reported 15 veteran cases – 6 month total -- before the Montgomery Circuit and District Courts and noted
that a "defendant has to identify themselves as a veteran so this may not capture everyone that is a veteran." (Special
report produced at the request of Maryland Delegate Charlotte Crutchfield, District 19, July 2024) Prince George's had
19 veteran clients and Anne Arundel, 42 clients as of end-year 2024; i.e.,12-month totals. No data is available for the
recently created VTC in Washington / Frederick Counties (November 2024), nor Carroll and Howard Counties.

State grants, non-profit organizations and veteran service organizations are available to support the work of a County VTC. A formal estimate of cost and supporting resources is part of the formal application process required by the State.

We are pleased to note that District Administrative Judge Sherri Koch has expressed interest in submitting an application to the State Office of Problem-Solving Courts to establish a Veterans Treatment Court in Montgomery County.

We are concerned that our County may be leaving behind its justice-involved veterans. The Montgomery County Commission on Veterans Affairs strongly recommends and requests your endorsement of the establishment of a Veterans Treatment Court as soon as possible.

PROCLAMATION - OPERATION GREEN LIGHT FOR VETERANS

WHEREAS, residents of Montgomery County, Maryland have served with courage and loyalty in every major military conflict since 1776; and

WHEREAS, those that have given their lives defending the principles of freedom during these conflicts are and forever will be deserving of the highest gratitude and honor by the people of Montgomery County; and

WHEREAS, Montgomery County, as a Green Light for Veterans County, seeks to honor individuals who have made countless sacrifices for freedom by placing themselves in harm's way for the good of all; and

WHEREAS, over 36,000 county veterans continue to serve our community in the American Legion, Veterans of Foreign Wars, Commission on Veterans Affairs, religious groups, civil service, and by functioning as County Veterans Service Officers in 29 states to help fellow former service members access more than \$52 billion in federal health, disability and compensation benefits each year; and

WHEREAS, Montgomery County appreciates the sacrifices of our Armed and Uniformed Services personnel and believes specific recognition should be granted.

NOW, THEREFORE, BE IT RESOLVED that Marc Elrich, County Executive, Kate Stewart, Council President, and the entire Montgomery County Council hereby declare November 4th through Veteran's Day on November 11th, 2025 as:

Operation Green Light for Veterans

which is a time to salute and honor the service and sacrifices of our men and women in uniform transitioning from active service. Montgomery County, in observance of Operation Green Light, encourages its residents to recognize the importance of honoring all those who made immeasurable sacrifices to preserve freedom by displaying green lights in a window of their place of business or residence from November 4th through the 11th, 2025.



On November 4, 2025, Council President Kate Stewart and Dr. Earl Stoddard, assistant chief administrative officer, on behalf of County Executive Marc Elrich, present a proclamation recognizing Veterans Day and Operation Greenlight for Veterans.

Montgomery County Executive Marc Elrich and County Council President Kate Stewart were joined by members of the Council, Montgomery County Department of Transportation (MCDOT) Director Chris Conklin, and community leaders for the launch of the County's Operation Green Light Initiative and the unveiling of the Ride On "Operation Green Light" themed bus at a ceremony to honor veterans.

Speakers and community leaders arrived in MCDOT's #OperationGreenLight Ride On bus, which is wrapped in a design depicting the U.S. flag, an outline of veterans, and highlighting Operation Green Light, a campaign honoring Veterans. The Montgomery County Veterans Affairs website and resource line is printed on the back of the bus. Internal bus cards on nearly 400 MCDOT Ride On buses will share resources with veterans throughout November.

The ceremony commenced with the singing of the national anthem by Richard Montgomery High School students Nala Ashe-Moncet and Alexa Thompson.

Dr. Lolita Weedon, U.S. Army (Ret.), with the Montgomery County Office of Human Resources served as Master of Ceremonies.

MONTGOMERY COUNTY FALLEN HEROES HISTORY

In June 2009 family members came to the Commission meeting and requested the help of the Commission in renaming the Rockville Library to Rockville Memorial Library. These family members that attended were Richard and Lee Ann Doerflinger – son Army Specialist Thomas Doerflinger killed in Mosul, Iraq on Veteran's Day November 11, 2004, Paula Davis – son Private First Class Justin Ray Davis. U.S. Army killed on June 25, 2005 in Afghanistan, Tom and Carol Barbieri - son Army Specialist Thomas Joseph Barbieri II, 82nd Airborne Division, killed on August 23, 2006 south of Baghdad Iraq, and Nikki Bunting, wife of Captain Brian "Bubba" Bunting, U.S. Army, killed on February 24, 2009 in Kandahar, Afghanistan, and her sister Tracey Paul all expressed their strong belief that to honor their family members, they request that the Rockville Library be renamed to the Rockville Memorial Library, to honor fallen soldiers. The Commission took on the mission of getting the Rockville Library renamed to the Rockville Memorial Library. Letters were written to the County Executive and the mission was accomplished in that a formal ceremony marking the official renaming of the Rockville Library to the Rockville Memorial Library was held on Friday, May 28, 2010 at 11 a.m. in the front of the building at 21 Maryland Avenue, Rockville. But following the meeting where family members came, the very next day Carly Clem and Betsy Luecking, staffers to the Commission, sat down to discuss what we as staff could do immediately to honor the fallen so that they would not be forgotten by our community. It was decided they would build a website with photos of the fallen, whatever background could be found. This was not an easy task as there were no lists and much research needed to be done. Research included visiting the National Archives in College Park, reviewing census and military records on Ancestry.com and researching article on newspapers, going to high schools to look at yearbooks, and the lists published by the Department of Defense. As time went on, they were able to research those killed in action from the Gulf War, Vietnam War, Korean War, World War II and World War I. This website contents are on digital displays at the Rockville Memorial Library lobby and the Silver Spring Civic Building at Veterans Plaza in the front entry. In tribute to those who served and for the family members, Carly Clem did most of the research, creation of websites and digital display in an outstanding way.



RETIRED NAVY COMMANDER EVERETT ALVAREZ, JR. PROCLAMATION MARCH 2025

Retired Navy Cmdr. Everett Alvarez Jr., a distinguished Vietnam War veteran and former Prisoner of War has been selected to receive the prestigious Congressional Gold Medal in recognition of his exceptional service to the United States. This highly coveted award is one of the highest civilian honors in the U.S., presented to individuals whose contributions to the nation have been extraordinary. Alvarez is one of only 184 individuals in history to receive this honor, highlighting his remarkable sacrifice, leadership, and long-lasting impact. In addition, Secretary of the Navy Carlos Del Toro recently announced that he is naming a future guided missile frigate after Everett Alvarez, Jr.

CDR Alvarez was the first American aviator taken captive in Vietnam after being shot down in 1964 near Hanoi. He became the second longest-held U.S. prisoner of war (POW) in U.S. history. He spent eight years and seven months as a prisoner of war. His capture and time in captivity became emblematic of the sacrifices made by POWs, and his perseverance and courage in the face of adversity continue to inspire veterans and civilians alike. He holds numerous military decorations including the Silver Star, two Legions of Merit, the Distinguished Flying Cross, two Bronzes Stars, and two Purple Hearts He went on to serve as Deputy Director of the Peace Corps, Deputy Administrator of the Veterans Administration (now known as Department of Veterans Affairs) where he helped pioneer the VET centers for combat veterans and we have one here is Silver Spring, vice president for government services with the Hospital Corporation of America and is a former member and chair of the Uniformed Services University (USU) Board of Regents.

In recognition of his lifetime achievements, the U.S. Congress named a post office in Rockville, Maryland, in his honor in 2000. Additionally, in 2008, Alvarez was named one of the "25 Greatest Public Servants of the Past 25 Years" by the Council for Excellence in Government. He and his wife Tammy have made Rockville Md their home since 1976.

MONTGOMERY COUNTY EXECUTIVE MARC ELRICH JOINS TRIBUTE HONORING TUSKEGEE AIRMAN AND WWII VETERAN BRIGADIER GENERAL CHARLES E. MCGEE - MEMORIAL UNVEILING

County Executive Marc Elrich, County Councilmembers and other state and federal elected officials joined the Distinguished Flying Cross Society (DFCS) on Thursday, Dec. 5, for a ceremony to unveil a memorial honoring the late combat veteran Brigadier General Charles E. McGee. The event took place at the Brigadier General Charles E. McGee branch of the Montgomery County Public Libraries in Silver Spring. Brigadier General McGee, a proud resident of Montgomery County who passed away in 2022, is being remembered just days before what would have been his 104th birthday on Saturday, Dec. 7. "Brigadier General Charles McGee's extraordinary service and leadership continue to inspire us all," said County Executive Elrich. "We are honored to celebrate his legacy here in Montgomery County, a place he proudly called home, and to recognize his lasting impact on our nation's history and the future of young leaders who continue to look up to him. It is fitting that this memorial is in the library and in a place where it will be seen by many so that his contributions are remembered by children and adults who may not know this history."



More than 50 individuals attended the ceremony, including representatives from the Eastern Region of the Tuskegee Airmen, the Boy Scouts of America and the Montgomery County Commission on Veteran Affairs. The Young Marines served as the event's color guard.

"As a famed Tuskegee Airman who flew over 400 combat missions, Charles McGee didn't just break records – he broke barriers. That is why I worked to honor his heroism by authorizing his honorary promotion to the rank of Brigadier General. This memorial will help serve as a reminder of his life's work: defending our country and demanding that it live up to its full promise," said U.S. Senator Chris Van Hollen (D-Md.).

During the ceremony, a monument commissioned by the DFCS was unveiled. Military leaders, including General Ronald Fogleman and Lewis Watt, a Vietnam War veteran and Distinguished Flying Cross recipient, participated.

"The Distinguished Flying Cross Society thanks the officials of Montgomery County for allowing our representatives to host the dedication of a National Distinguished Flying Cross Memorial at the McGee Library, in honor of the legacy of Brigadier General Charles McGee," said J. Bruce Huffman, chairman emeritus of the DFC Society. "This dignified event is in keeping with our mission to 'honor, preserve and teach' the legacy of our members who are recipients of the Distinguished Flying Cross."

BRIGADIER GENERAL CHARLES E. MCGEE MEMORIAL UNVEILING CONTINUED

Brigadier General McGee, a trailblazer in American military history, was a member of the Tuskegee Airmen, the first all-Black combat aviator group in the United States Army Air Forces. Throughout his distinguished career, he flew 409 combat missions across three wars—World War II, the Korean War and the Vietnam War. His exceptional service earned him numerous honors, including two Legion of Merits, three Distinguished Flying Crosses, a Bronze Star, 26 Air Medals and the Congressional Gold Medal.

"As the Councilmember representing Silver Spring, I am proud to have our local library named after Brigadier General Charles McGee," said Montgomery County Council President Kate Stewart. "We are delighted to see the new memorial for General McGee installed and appreciate the work of the Distinguished Flyers Cross Society in honoring his service."

Beyond his military accomplishments, Brigadier General McGee continued to lead after retirement. He served as director of the Kansas City International Airport and worked to preserve and promote the legacy of the Tuskegee Airmen through public education and the entertainment industry. His personal mantra, "Perceive, Prepare, Perform and Persevere," remains a source of inspiration for future generations.

"The Brigadier General Charles E. McGee Memorial is about more than honoring a hero—it is about sharing a story of resilience, bravery and service with our community," said County Council Vice President Will Jawando. "For years to come, every person who uses the Library in Silver Spring will have the opportunity to learn about a true American hero. His life reminds us that with courage and integrity, we can overcome any challenge and make the world a better place."

In February 2022, shortly after Brigadier General McGee's death at 102, Montgomery County renamed the Silver Spring Library in his honor.

"Brigadier General Charles McGee embodied the value of lifelong learning that drives the mission of our Montgomery County Public Libraries today," said District 5 County Councilmember Kristin Mink. "In Montgomery County, we honor General McGee every day by joining in the important work of teaching the complex and sometimes uncomfortable history of our County and country and by supporting our public libraries in their vision of supporting lifelong learning for all of our residents of every background and origin."

The memorial is on the third floor of the Brigadier General Charles E. McGee Library, located at 900 Wayne Ave. in Silver Spring.

PROJECTED NUMBER OF VETERANS IN MONTGOMERY COUNTY, MD

The U.S. Census Bureau 2024 American Community Survey estimates that there are approximately **37,628 veterans living in Montgomery County, Maryland**. That is an **increase of 1,039 veterans** since last year's census. According to the American Community Survey, 5.9% of all Americans self-reported as being a veteran. The Census Bureau defines veteran as men and women who have served (even for a short time), but are not currently serving, on active duty in the U.S. Army, Navy, Air Force, Marine Corps, or the Coast Guard, or who served in the U.S. Merchant Marine during World War II. People who served in the National Guard or Reserves are classified as veterans only if they were ever called or ordered to active duty, not counting the 4 to 6 months for initial training or yearly summer camps. All other civilians are classified as nonveterans.



HOW TO ENROLL IN VA HEALTHCARE

There are an estimated 37,628 Veterans living in the County and only an estimated 11,731 are enrolled in the VA Healthcare system. Given that the County has a Community Based Outpatient Clinic located in Gaithersburg, the Commission on Veterans Affairs is encouraging Veterans to enroll now. The very first step in obtaining access to your VA Health Benefits is to apply for enrollment.

Once enrolled, you can begin enjoying your VA health care benefits. New enrollees will receive a Welcome to VA telephone call from VA staff and a personalized Veterans Health Benefits Handbook in the mail. During that call, we can answer many of your initial questions, provide information regarding your health benefits and other services provided through VA and schedule your initial VA health care appointment. The handbook will detail your VA health care benefits information, based on your specific eligibility factors, in an organized, easy-to-read format. It also includes information on your preferred facility, copayment responsibilities, how to schedule appointments, ways to communicate treatment needs and more. VA MENTAL HEALTH RESOURCES

APPROACH

For the U.S. Department of Veterans Affairs (VA), nothing is more important than supporting the health and well-being of the Nation's Veterans and their families. A major part of that support is providing timely access to high-quality, evidence-based mental health care. VA aims to address Veterans' needs, during Service members' reintegration into civilian life and beyond.

The <u>VA Office of Mental Health and Suicide Prevention Guidebook</u> provides information on the variety of mental health services that VA offers on both a national and local level. These programs and services are rooted in several core values:

FOCUS ON RECOVERY

Whether a Veteran is facing a <u>mental health</u> concern, <u>substance misuse</u>, the effects of <u>military sexual trauma</u>, or any of life's challenges, focusing on healing and recovery empowers them to take charge and live a fuller and more meaningful life. This approach builds on a Veteran's strengths and offers respect, honor, and hope - to both the Veteran and the family members who support them.

EVIDENCE-BASED TREATMENTS

Evidence-based treatments are those that have proved effective for a particular mental health condition. These scientifically tested courses of treatment include a range of therapies and medications. At VA, evidence-based treatments are tailored to each Veteran's needs, priorities, values, preferences, and goals. Many may work quickly, sometimes within a few weeks or months, depending on the nature or severity of symptoms. To learn more:

MEASUREMENT-BASED CARE (MBC)

<u>Measurement-based care</u> (MBC) provides Veterans the opportunity to take an active role in their mental health care. In MBC, the Veteran is part of their own treatment team, working with their providers to set recovery goals, develop treatment plans, establish benchmarks, and monitor progress. The treatment is tailored to the individual Veteran's specific needs, and the metrics gathered along the way are used to determine whether treatment is working as planned or needs to be adjusted. VA is working to ensure that MBC is part of every one of its mental health programs.

COORDINATING CARE FOR THE WHOLE PERSON

Timely medical care, good nutrition, regular exercise, a sense of purpose, and supportive family members and friends are just as important to mental health as they are to physical health. That's why VA health care professionals work together to provide safe and effective treatment for the whole person - head to toe, inside and out - using what's known as a "whole health" approach. Through VA Whole Health, Veterans take an active role in their care by partnering with their providers to achieve and maintain their optimal health and well-being. It all starts with answering a simple question: What matters most to you?

ROUND-THE-CLOCK SERVICE

Emergency mental health care is available 24 hours a day, seven days a week, at VA medical centers (VAMCs). Facilities that don't have a 24-hour emergency room provide these services through a local, non-VA hospital. Telephone evaluations at VAMCs and the <u>Veterans Crisis Line</u> are also available around the clock every day.

VA residential rehabilitation treatment, sometimes referred to as inpatient residential or domiciliary care, provides comprehensive treatment and rehabilitation services to Veterans with mental health conditions like PTSD, depression, and substance use disorder. The programs take a whole health approach to address challenges these Veterans may experience, including medical concerns and social needs such as employment and housing. <u>Learn more about residential rehabilitation and how to apply.</u>

ABOUT VA MENTAL HEALTH RESOURCES CONTINUED

PEER SPECIALISTS

Peer specialists are trained and certified in offering mental health support. As Veterans themselves with personal experience of recovery from mental health conditions, they help other Veterans identify and achieve specific recovery and wellness goals. Peer specialists are found in many types of VHA settings and can provide support in several ways, including:

- Serving as role models by sharing their recovery stories.
- Collaborating with health care professionals to support Veterans' goals.
- Helping Veterans develop and enhance problem-solving skills.
- Helping Veterans identify their strengths, their skills and the resources needed to achieve their goals.
- Coaching Veterans on developing self-help skills to independently manage their health conditions.
- Empowering Veterans to speak up about their mental health concerns.
- Informing Veterans about available VA and community resources.
- Inspiring Veterans to see their own potential and believe that they can achieve wellness and their personal goals.

Veterans who want to work with a peer specialist can obtain a referral from their current VA health care provider.

CARE CLOSE TO HOME

To improve Veterans' access to care, VA is adding more rural and mobile clinics and working with health care providers in smaller communities. VA also uses cutting-edge technologies – including <u>mental health</u> <u>care by phone or secure video</u>, self-directed <u>apps</u> for smartphones, and text-based support - to deliver care to Veterans when they need it, wherever they are, even in the comfort of their own homes.

Readjustment Counseling Services

After war, some veterans experience psychological and social distress and difficulties in readjusting to civilian life. In 1979, the Department of Veterans Affairs established Vet Centers to assist Vietnam-era veterans with such problems. Congress later expanded Vet Center services to include combat veterans of other conflicts. These services are available at Vet Centers in all 50 states, Puerto Rico, the US Virgin Islands and Guam.

Services Available

- Individual counseling
- Marital and family counseling
- VA benefits assistance and referral
- Substance abuse counseling and referrals
- Primary health care for basic medical needs
- Pre-employment assistance and employment counseling
- Discharge upgrade information
- Community, social service and medical referrals
- Sexual trauma / harassment counseling

The Vet Center also has a network of federal, state, city and community resources to help you. They will try to address any concerns or problems you bring to them.

At the Vet Center, you can expect help from professional counselors who will treat you with respect and understanding. Many of the counselors are also war veterans, so they understand your problems firsthand, and have the training and skills to help solve them.

There is no charge for the assistance you receive at the Vet Center because of your sacrifices and efforts for this country. Veterans applying for assistance are asked to bring a copy of their Military Separation or Military Discharge (DD214) with them. VA Vet Centers provide readjustment counseling to Veterans with dishonorable discharges.

- Routine medication are ordered and delivered via US Postal mail from the DCVAMC (usually 5 to 7 days).
- Veterans may pick up medication from DC VAMC if needed urgently.

The Steven A. Cohen Military Family Clinic at Easterseals opened in September 2017 in Silver Spring, Maryland. The Cohen Clinic at Easterseals provides high-quality and accessible behavioral health care to the veterans, active-duty, and military families. Services are available to any person who has served in the U.S. Armed Forces, including the National Guard and Reserves, regardless of role or discharge status, and their families as defined by the service member such as: spouses or unmarried partners, children aged 4 and older, parents, siblings, caregivers, survivors, and other household members.

The Cohen Clinic at Easterseals uses evidence-based practices with a holistic approach to improve the quality of life for veterans and military families. Services are provided by culturally competent, trained, and credentialed staff. Veterans and military family members can receive services individually or as a family unit at the same clinic. We offer individual, couples and family therapy. In addition, the Cohen Clinic at Easterseals can also help connect veteran and military families to community resources and services, as necessary. Services are available to those in D.C., Maryland, Virginia and West Virginia (in person, or Telehealth), as well as in PA, NJ and DE (all via Telehealth).



The Maryland Department of Veterans and Military Families (DVMF) was created by the State Legislature in 1999 as an executive agency with the mission of *leading veterans*, *service members*, *and their families through life's transitions*. The Department's origin follows the history of the Maryland Veterans Commission back to 1924, when the Soldiers' Relief Fund Commission was formed to administer a State relief fund for disabled veterans of World War I.

Under the Department of Veterans and Military Families are five major programs:

- The Service and Benefits Program provides assistance to veterans, their dependents, and survivors in obtaining benefits from the U.S. Department of Veterans Affairs, Department of Defense, State of Maryland and other programs for veterans and their families. DVMF Veterans Benefit Specialists (VBS) are located statewide to provide benefits information and assistance to veterans and family members. For best results, DVMF encourages veterans and family members seeking information or assistance to work with an accredited DVMF VBS. Visit the service program or call 1-800-446-4926 ext. 6450 for information on benefits and service office locations.
- The **Charlotte Hall Veterans Home** offers a 168-bed assisted living program, 286-bed skilled nursing program, and memory care in secure units.
- The **Cemetery and Memorial Program** offers our honored veterans and their eligible dependents a final resting place at one of five state veterans cemeteries located throughout Maryland.
- The **Communications**, **Outreach**, **& Advocacy Program** works closely with multiple local, state and federal agencies and non-profit organizations to coordinate efforts to locate and inform Maryland's veterans as well as to expand benefits and services available to Maryland veterans.
- The Maryland Veterans Trust Fund makes grants, funded by donations and contributions, to veterans
 and their family members who are in dire financial situations or to private organizations that help
 veterans.

Constituent Resource Coordinator

A dedicated DVMF constituent services coordinator can help veterans and military families find the support they need by responding to questions and concerns about benefits. The coordinator works closely with federal, state, and local agencies to ensure constituents receive timely resolutions and access to resources.
