Welcome - Barbara Selter, Chair

Chair Barbara Selter welcomed everyone and took roll. She asked that all participants use the reaction button when they wish to speak. Ms. Selter announced that she would be asking about new business at the start of the meeting to get a sense of how much time to leave at the end of the meeting for new business. Finally, Ms. Selter asked that everyone speak respectfully and avoid hurting others. Art Williams stated that he would be signing off as he does not wish to play games and that Monique is no longer his liaison.

Discussion on COA Administrative Procedures - Odile Brunetto, Chief, A&DS

Odile Brunetto thanked the Commissioners for their work and thanked Barbara Selter for her testimony on November 17. Ms. Brunetto then noted that there are four items that all Montgomery County Boards and Commissions should know:

- 1. Attendance: If a commissioner misses three meetings in a rolling year, that commissioner is automatically removed from the Commission. The commissioner can write a letter to the County Executive to ask to be reinstated.
- 2. Open Meeting Act: Commissioners must attend training to learn the rules. More information is available in the Orientation Book.
- 3. Decorum and Commission Conduct During Meetings: Guidelines are in process.
- 4. Upcoming Elections: Commissioners are prohibited from political activity in their role as commissioners, but are allowed to be politically active as individuals

AAA Director Update - Dr. Patricia McGhee, Director of AAA

- Montgomery County (MC) completed a 2-year job classification study across County government. Several positions in AAA were recommended for upgrades or downgrades. Responses to the study are due November 20.
- HUBS: Eight community-based hubs were established as part of the County's pandemic response. Since the HUBS serve many older citizens, AAA will partner with them and provide written resources and staff. Under a pilot program with the Aging, Disability and Resource Unit (ADRU), ADRU staff go to the HUBS to provide resources and outreach. The materials include a Resource Fact Sheet that Dr. McGhee will forward to Jean Dinwiddie and Beverly Rollins so that the Communications Committee can promote it. Also, the AIC will learn more about HUBS.
- The MD Department of Aging offers a free daily wellness telephone check open to anyone who registers. There are daily robocalls plus a live volunteer once a week. If there is no response to a call three days in a row, the emergency contact will be notified. If the emergency contact cannot be reached, local authorities are contacted to conduct a wellness check.
- African-American Program: Dr. McGhee's presentation to this group will be forwarded to the Commission.

Primer on HCBS in MC—Jennifer Long and Shawn Brennan, A&D

This excellent presentation focused on home care and in-home supports. Services generally cost between \$18 - \$30/ hour and most people pay out of their own pockets. However, there are

Medicaid and Medicaid waivers subsidies available to those who meet income eligibility requirements. The best way to connect with programs (including Community Personal Assistance Services, Community First Choice and Community Options Waivers) is to call the Aging & Disability Resource Unit (ADRU) at 240-777-3000. ADRU conducts a level one screening and refers to Adult Services Intake Unit (ASI) for more complex screening. Based on its screening, ASI might refer to Adult Protective Services (APS), In-Home Aid Services or something else. Most important is to know to call the 3000 line to begin the process of obtaining services. Unfortunately, the State review process for financial eligibility for Medicaid-funded services can take up to a year. Non-Medicaid available programs include Senior Care, a statewide program (with a waiting list) that provides eligible seniors with gap-filling funds; In Home Aid Service (IHAS), serving 20 clients; respite services; and Department of Housing and Community Affairs (DHCA) community grants, which funds home care. There are many programs, but there are more potential clients on the waiting list than actual clients being served.

Issues and potential ways to address them:

- There is a long wait for care because of bottlenecks at various stages of the process. More staffing might help.
- Residents may qualify for home care, but there is insufficient funding to provide it. Lobbying for more funding might help.
- Many residents are not eligible due to income. Providing services to this Gap population might help.

Ms. Rollins is awaiting two letters of recommendation that Art Williams is compiling.

Due to the Legislature's Special Session, the date of the Legislative Breakfast was changed to December 16. Topics and speakers are: Gap population with Neal Brown or Marsha Weber; nursing facility survey issue with Dick Jourdenais; and HCBS waiver program with Morris Klein.

The Public Forum will be held on May 5 at the Gaithersburg Art Center and will be cohosted by the Gaithersburg Senior Advisory Committee. The theme is HCBS with a focus on home care.
