**Autism Waiver** provides service coordination to children diagnosed with severe autism, ages birth - 21 years, who are currently enrolled in the Autism Waiver program.

**Coordination of Community Services:** Assists individuals with developmental disabilities who receive funding from the Developmental Disabilities Administration (DDA) in obtaining the best quality and most appropriate services and supports with available resources within the community. Resource Coordinators provide case management and advocate for individuals receiving services.

**My Turn Program** provides short term or one time only financial assistance to caregivers of children ages 3 to 18 years with developmental disabilities and assists caregivers with accessing information, linking to other community resources and designing individual support services.

**Transitioning Youth** program assists students ages 14 to 21 years with developmental disabilities in the process of exiting from the school system, and their families with transitioning into adult services for ongoing supports through the DDA. Services include adult vocational training, day habilitation, or supported employment services.

Non-profit, non-public, co-educational, special education and related services program which serves students with developmental disabilities including autism spectrum disorders and other related disabilities. Across all programs students receive the following: therapeutic services plus academic, social and practical skills instruction; evidence-based practices, including applied behavior analysis, systematic teaching, and data-based programming, utilized across language-rich environments, including the classroom, school, and community; art, adapted physical education, library, and technology components; as appropriate, community-based instruction, recreational activities, career development and other transition services support students in achieving their highest level of development; academic interventions, and any additional services, accommodations, and supplementary aids outlined in a student's Individualized Education Program (IEP); and universal design for learning and assistive technology support student learning to give students access to the general education curriculum.

**Aspire School Program** offers two learning paths: a Diploma (grades K-12) and a Certificate of Completion (ages 4-21) across Elementary/Middle, High School and Post High School Programs. All students access the general education of their state and local school system. Teachers differentiate content to allow for a variety of instructional methods.

**Ivymount Endeavors School Program** offers two learning paths: Diploma (grades K-8) and Certificate of Completion (ages 4-21). While the curricula vary for these two paths, the approach and instructional

techniques are consistent. All students access the general education of their state and local school system. Also provide explicit and systematic instruction in skills necessary to live, work, and engage in recreational activities in the community. Teachers differentiate content to allow for a variety of instructional methods, including one-to-one/discrete trial instruction, small and large group instruction, direct instruction, and incidental and contextual teaching.

**Project SEARCH** is a unique one-year school-to-work program designed to help young adults with significant disabilities make successful transitions from school to productive post-school life. Project SEARCH learning takes place entirely in the workplace. Employment immersion facilitates a seamless combination of classroom instruction, career exploration, and on-the-job training and support through worksite internships. The program model includes an extensive period of training and career exploration, innovative adaptations, long-term job coaching, and continuous feedback from teachers, job coaches, and employers.

Early Childhood Education program serves children birth through 8th grade with varying hearing levels as well as children who are deaf or hard of hearing with additional disabilities. The program utilizes the Teaching Strategies Gold curriculum and its online assessment tool and portfolio. The staff monitors the development of both ASL and English using the Visual Language and Visual Learning (VL2) assessment tool as well as tools for spoken English. From kindergarten through eighth grade, students experience hands-on learning that is academically rigorous, IEP-driven, and aligned with the Common Core State Standards. Located on Gallaudet's campus. Tuition is free and students come from the Metropolitan Washington, D.C. area.

Behavioral Health Services: Arrange mental health services for children; student support groups; medication evaluation and psychiatric care; child, family, and group counseling; school support services; and crisis intervention. Additional Health Services (available at school-based Health Centers): Provide physical examinations and immunizations; medical care or referral for children with acute and chronic illnesses; routine or emergency health services; prescription medicine; and health and nutrition education.

**Early Head Start and Head Start Program** provides comprehensive, year-round, child and family development services to low-income families with children from birth to five years old. Parents are assisted with transitioning their children into Head Start or other preschool programs when the child reaches age three. Families are linked to community resources such as food, clothing, housing, childcare, employment, English classes, health care and mental health counseling.

**Lourie Center School** serves children 4 to 12 years of age (including grades N4, kindergarten, and one to five) with emotional disabilities and/or multiple disabilities that interfere with learning, functioning and availability for learning in a typical classroom setting. The curriculum is based on a multidisciplinary approach to childhood education and the treatment of emotional disabilities. The school provides academic instruction, mental health and play therapy, speech and language therapy, and occupational therapy as well as psychiatric consultation as needed.

**Therapeutic Nursery Program** has two specialized preschools that address the needs of young children 3 and 4 years of age with emotional and behavioral problems that may interfere with success in a regular setting. The program addresses the needs of young children with emotional and behavioral problems that may interfere with success in a regular preschool or day care setting. Without intervention these difficulties

and behaviors may place the child at risk for school failure. The program fosters appropriate social, intellectual, emotional, and physical growth in each child. The **Parent-Child Clinical Services Program** is a licensed outpatient mental health clinic that offers a comprehensive approach to the early identification, treatment and prevention of emotional, behavioral and developmental problems in infants, young children and their families. Using a family-centered, developmental approach, the multidisciplinary staff members provide a wide range of assessment, treatment, consultation and training services to promote children's healthy development, enhance parenting capacities and foster positive parent-child relationships.

Children and youth from out-of-state who are Deaf and Hard of Hearing who meet the MSD admissions criteria may attend our program by paying tuition. Utilize a general education curriculum as well as the voluntary state curriculum. Students are immersed in educational, developmental, and extra-curricular activities. **Autism Support Group:** MSD offers an Autism Support Group open to MSD parents and those across the State of Maryland, who have a deaf/hard of hearing child with Autism. The group is designed to be a welcoming environment for families and caregivers of children who are deaf with autism spectrum disorders to meet, share experiences, ask questions, and receive support. **Family Support and Resource Center:** This statewide support service is for families with children who are deaf and hard of hearing. This resource center provides information to families regarding community services; refers families to local support groups, workshops, and advocacy groups; and provides opportunities for families to network and share ideas and experiences.

Promote access to care, ensure all youth have a successful transition to adulthood, and build equitable opportunities for all children and youth to thrive. The Collaboration Council partners with agencies that deliver youth and family- driven culturally competent services and supports for youth with behavioral health challenges to promote success in school, strengthen bonds in the family, and develop ways of coping and overcoming emotional and behavioral problems.

**Pathway to Services** helps children and their families connect with community-based services and supports that exist in Montgomery County. Pathways works with families with Medical Assistance, private insurance or families that are uninsured. **Local Care Team (LCT)** is the next stop in the system of care for many families. As an interagency team of public child-serving agencies along with consistent family-voice representation, the members problem solve how to best use local resources to keep the family intact and increase both adult and child/youth family members' functioning. The LCT is the pathway to wraparound services in the community. It also reviews cases of children and youth that meet eligibility to be placed in high-cost residential programs in-state or out-of-state. Wraparound Care is a strengths-based, family-driven process that puts in place an array of services and informal supports to help strengthen families and address emotional and behavioral concerns within the community. **MoCo Reconnect** is a resource for youth and young adults ages 16 to 24 who have either dropped out of or stopped attending high school. MoCo Reconnect is a collaborative of agencies in Montgomery County who provide outreach, case management, education, training, and employment services. Staff help youth reconnect to educational options, pursue a high school diploma or GED, and receive job training. (<https://mocreconnect.org/>)

The transition services unit provides stakeholders with the necessary resources, tools, supports and professional development needed to ensure students a successful transition into further education, employment, and full participation in their community.

**Transition Planning Process:** Transition services are a student-centered planning process that is designed to meet the students educational, employment and independent living outcomes. These outcomes may include postsecondary education; job training; employment (supported); continuing and adult education; adult services; and independent living.

**Community participation:** A student's transition plan becomes a part of the Individualized Education Program (IEP) process beginning at age 14 or younger, if appropriate. Transition planning is a process that should include the following: identifying the student's post-high school goals; assessing the student's interests and abilities in relation to identified goals; determining courses, experiences, and programs that will prepare the student to reach his/her goals; supporting the student in transition-related activities; determining the student's anticipated adult service needs; and linking the student and parent with potential adult services. Students receive an array of services to help them

attain their identified post-secondary outcomes and to prepare them to be college, career and community ready. These services may include, but are not limited to; career education, career exploration, social skills and self-advocacy instruction, career technology education, in-school and community work-based learning experiences, independent living skills instruction, and linkage to community agencies.
