**HomeAbility:** A special product designed to assist Maryland homebuyers with disabilities to finance their home purchase. This is a Conventional Loan product and provides up to 95% LTV in a first lien and up to 25% (with a maximum of \$45,000) in a second lien to assist with down payment and closing costs. The combined LTV may not exceed 105%.

Program designed to reduce the incidence of homelessness in Montgomery County by providing permanent supportive housing for those individuals and families that live in emergency or transitional shelters which include hotels/motels, are exiting an institution and/or sleeping in a place not designed for regular sleeping accommodation, including cars, parks, bus/train stations, camping grounds etc. All HIP participants are referred from the Montgomery County Coordinated Entry System (CES) and are assessed for Permanent supportive Housing.

A tenant-based rent subsidy program. This program allows eligible DDA/DHCD RSP participants to search for a unit that meets their needs in the community of their choice. Units chosen by participants can rent for no more than the maximum Fair Market Rent (FMR) for the area in which the unit is located (as determined by the U.S. Department of Housing and Urban Development (HUD)). Program participants will pay 30% of their total household income for rent and utilities. The DDA/DHCD RSP will pay the difference between the rent the program participant pays and the total rent for the unit. DDA will: provide funding for the DDA/DHCD RSP; verify that applicants are receiving services funded by DDA or are on the DDA Waitlist in the Crisis Resolution category; oversee DDA/DHCD RSP program operations; and assist housing support service (HSS) providers, landlords and program participants with any issue that could affect the program participant's continued tenancy. Referrals to Housing Support Provider agencies are made by the person's Coordinator of Community Services. Only Housing Support Service specialists can place someone on the waitlist for this program.

Full residential services focused on individualized support can be provided to adults with disabilities at one of 35 single-family homes, townhomes or condos owned or operated by The Arc Montgomery County. Regardless of the setting, every individual enjoys a private bedroom. Support services may include personal care, medication administration, use of community services, meal preparation, recreation, financial management and health care coordination. A continuum of services can be provided from early adulthood through senior years, and annual team meetings with staff, relatives, friends and other service providers is an avenue for setting goals and evaluating outcomes. During weekdays, all participants must be involved in education, work, volunteer service or senior living activities in the community. Evening and weekend

activities are based on individuals' interests and typically include fitness and exercise, dining out, shopping, volunteer work, music and art activities, movies, and parties or holiday celebrations. Individuals must apply to the Maryland Developmental Disabilities Administration for eligibility and funding approval.

CSS currently operates 60 homes, and individuals have choices of the housemate they prefer and the residence best suited for them. Individuals, participating in Supported Living, receive support to live in their own home, outside the family home. The individual may live alone or with a housemate and is responsible for room and board expenses and the management of the home. CSS provides staff support as requested to pursue person-centered goals to increase independence and community membership.

Works in partnership with families, volunteers, donors and communities to build homes and provide an affordable mortgage to low and moderate-income families with the dream of homeownership.

**Home Purchase Program:** Ensures that qualified buyers pay an affordable mortgage. HFHMM will evaluate all applications based upon three main criteria: need, ability to pay and willingness to partner. You must have lived or worked within Montgomery or Prince George's County for at least one year; you must contribute up to 500 hours of sweat equity based upon family size; proof of Citizenship or Permanent US Residency; habitat homebuyers must have an annual household income between 30% to 60%, and in some cases up to 80% of the AMI (Area Median Income) as determined by HUD.

**Home Repair and Weatherization:** Provide low-cost home repairs and weatherization services to address health and safety issues, energy efficiency improvements and/or code violations to qualified Montgomery County and Prince George's County homeowners. Not an emergency program.

**Veteran Repairs Program:** A construction-based resource aimed at identifying and addressing health and safety related repairs to the homes of qualified families in Montgomery and Prince George's Counties. Funding for the Veteran Repair Program comes, in part, from the Home Depot Foundation, and allows HFHMM to serve the critical repair needs of Active Duty and Veteran households in the community.

**Repair and Accessibility Modification Program (RAMP):** A construction-based resource aimed at identifying and addressing critical health, safety and accessibility related needs in the homes of families where at least one household member struggles with one or more Activities of Daily Living (ADL's). The goal of this program is to provide owner-occupied homes with a safe, healthy, and accessible environment in a comprehensive way using the expertise of an Occupational Therapist (OT), and optional consultation with a Registered Nurse (RN) to determine best-fit accessible solutions for housing challenges.

**Habitat for Humanity Metro Maryland Continued Home Accessibility Rehabilitation Program (HARP):**

A free program through the Department of Housing and Community Affairs, administered by Habitat for Humanity Metro Maryland. The goal of this program is to provide owner occupied homes with accessibility modifications. Eligible items include grab bar installation, stair lift installation, tub cut or walk-in shower conversion, indoor/outdoor railing installation, and ramp installation. Qualifications: be a current resident of Montgomery County; own and occupy the home where services are requested; at least one home occupant over the age of 65 and/or has a physical disability; have current homeowners' insurance; be income qualified. There is no repayment for participants.

Operates ten permanent supportive housing (PSH) programs to connect people who have experienced homelessness to stable, permanent housing along with the services they need to ensure they never experience homelessness again. Each year, MCCH serves nearly 800 men, women, and children, including veterans, living in 400+ households throughout Montgomery County. All PSH clients receive two critical types of support in order to remain in stable housing:

- **Rental Assistance:** PSH clients pay 30% of their income towards rent, regardless of the source or amount of their income. The balance of their rent is paid through vouchers or MCCH funding.
- **Ongoing Supportive Services:** Each PSH client receives ongoing support from a dedicated case manager to address the issues that led to their homelessness and connect them to resources they need to remain stably housed.
- **Home Builders Care Assessment Center Men's Emergency Shelter** serves over 750 men annually with on-site support services from client support managers. Clients have access to case management; employment lab with an employment specialist; support with locating housing; medical, psychiatric and dental care; breakfast, lunch and dinner; bathrooms and showers; laundry facilities; beds in pods of six; and outdoor space.
- **Veterans Affairs Safe Havens Emergency Housing** serves over 55 veterans with severe and persistent mental illness or co-occurring substance disorders in two shared homes.
