#### SUMMARY WRITUP BY LISA LORRAINE (she/her)

"On October 23, 2023, a group of 20 disability organizations signed a letter showing demographic disparity data and making recommendations that would benefit traditionally underserved disability communities. I ask the Commission to support the recommendations in the Enriqueciendo Vidas letter (attached) through a formal letter of support, and by authorizing commission members to advocate for legislation that supports the recommendations on behalf of the commission. Specifically, we expect Del. Gabriel Acevero to introduce a bill in the 2024 session to require agency language access plans and compliance coordinators. Since the legislative session begins January 11<sup>th</sup>, I would hope to have the commission's support in place by our January meeting (Jan 18)."

#### **Need for Committee**

Hospital Stays Persons with intellectual disabilities.

People with intellectual disabilities have had negative experiences upon being admitted to the hospital. In some cases, the hospitals either lack the staff or the training to properly meet the needs of people with intellectual disabilities such as Autism. As a result, the tendency of the hospital staff is to discharge a person with developmental disabilities, even if they are medically fragile, and possibly would not be discharged under normal circumstances.

From the hospital's perspective, often a person with severe Autism (for example) exhibits behaviors the hospital feels they are not equipped to handle.

The result can be negative experiences while in the hospital for persons with intellectual disabilities, and in some cases a premature discharge from the hospital, resulting in negative medical outcomes.

Course of action for the Committee (Time frame to complete 1 year)

- 1) Identify the hospitals that operate in Montgomery County
- 2) (Secondary) Identify, non-hospital long term care facilities that operate in Montgomery County.
- 3) Gain an understanding of the law as it relates to patients' rights and hospital stays.


- 4) Meet with hospital administration to understand the following, and it relates to persons with intellectual disabilities.
  - a) Policies and procedures.
  - b) What training is conducted with staff and administrators.
  - c) Challenges they encounter, while serving people with disabilities.
- 5) Meet with providers in the County, to understand their perspective.
- 6) Meet with DDA, to review their new proposed Comar regulations involving hospital stays. (even the proposed DDA regulation of paying for staff support while a person is in the hospital, requires the "provider" to have written policy, which will require meeting with hospital administrators to help formulate.
- 7) Submit recommendations to the Commission on specific ways to strengthen the quality and experience of hospital stays for persons with intellectual disabilities.


How would you rate the overall quality of yesterday's meeting?


Did you feel you had ample opportunity to provide input?
