Question 1	Whether to recommend inclusion of a requirement for annual revalidation of registered information?
Question 2	Whether to recommend excluding public guardians from being able to register the people they serve as guardians into the registry.
Question 3	Whether to recommend that the Council require an annual report from MCPD on program participation by geography and metrics measuring improvement in police interactions to monitor the effectiveness of the registry program in advancing RESJ as recommended in OLO's RESJ Impact Statement.
Question 4	Whether to recommend enactment of the bill as introduced or whether to adopt the proposed amendments.?
Amend #1	An amendment to state that the information provided by registrants would be automatically purged annually unless the registrant renews the registration.
Amend #2	An amendment requested by Disability Rights Maryland that provides that for purposes of this section, guardian does not include a court-appointed public guardian

Amendment #3	An amendment to line 30 of Bill 33-22 as introduced to replace the term "[[Mental health disability]]" with the term "Behavioral health condition"
