Update:

- New Applicant Interviews: Pam, Chair and Irene interviewed 2 applicants for AODAAC positions. Names were forwarded to the County, then to the County Council. County executive nominates and the county Council confirms.
- Nominating Committee: Need three members to serve on the committee. These members can't run for office. Duties: Contact a potential member, review attendance of potential candidates. One person to serve as Chair, and two people to serve as Co Vice Chair for AODAAC next year. Members can also run from the floor at the June meeting. The nominee committee will organize a slate. Pam sent out the description for the position of Chair and Co Vice Chair. You must be a Voting Member to serve on the nominating committee and have no interest in running for office. Elyse asked for interest in serving on the nominating committee. Irene volunteered to serve on the nominating committee. Pam and Elyse will reach out to people to form the nominating committee.

Agency Mission (particularly as it relates to AODAAC):

MHAC was established to advise the Montgomery County Executive and the County Council on matters concerning mental health. MHAC's work includes providing citizen oversight to all state-funded mental health agencies serving Montgomery County and serving as an advocate for a comprehensive mental health system for persons of all ages. The Committee helps to ensure that publicly funded mental health services are responsive to local needs, accountable to the citizenry, and accessible to those in need.

Actions/updates since last report:

MHAC met on March 4, 2025. The planned guest speaker, Genevieve Diamond, LCSW-C, Team Leader, OnTrack Maryland, Shepherd Pratt, did not attend the meeting. Agency Mission (particularly as it relates to AODAAC):

The mission of the Department of Health and Human Services (HHS) is to promote and ensure the health and safety of the residents of Montgomery County and to build individual and family strength and self-sufficiency. The Behavioral Health and Crisis Services (BHCS) service area of HHS is committed to addressing the specialized Behavioral Health needs of Montgomery County.

- Montgomery County experienced a 40% decrease in fatal overdoses in 2024 when compared to 2023, surpassing the state decrease of 35%. Montgomery County's decrease includes:
 - o A decrease of 48% from 2023 for fatal overdoses involving opioids
 - o A decrease of 52% for fatal overdoses involving Fentanyl
 - o A decline of 18% for fatal overdoses involving alcohol
- This represents the lowest number of fatal overdoses (83) in Montgomery County since 2015.
 - The decline observed was mostly driven by age groups younger than 40 yrs, especially among those 22 yrs and younger.






• Similarly, in 2024 Montgomery County saw a significant decline of 30% in ER visits due to Opioid Overdoses as compared to 2023. This represents the first notable decline since the beginning of the Covid Pandemic.

Contributing Efforts:

• In FY24, the Montgomery County Department of Health and Human Services' Prevention and Harm Reduction team provided Narcan administration trainings to 4,879 individuals and distributed a total of 4,881 Narcan kits containing 9,762 doses, representing an 81% increase in Narcan kit distribution and 67% increase in individuals trained in Narcan administration as compared to FY22.

- In FY24, Montgomery County's STEER (Stop, Triage, Engage, Educate, and Rehabilitate) Program served a total of 592 county clients considered at high risk of overdose. Among these, 82% completed STEER screenings. Among those screened, 52% received a referral to treatment, and 57% of those referred were engaged in treatment after being referred.
- Montgomery County's Department of Health and Human Services' Crisis Stabilization
 Room admitted 409 individuals in 2024, with 287 (70%) of them presenting with
 substance use. The Crisis Stabilization Room provided timely intervention and care for
 those struggling with substance use issues and facilitated their connection to recovery
 pathways and supportive resources.
- In the Maryland Medicaid Public Behavioral Health system, a total of 5,342 County SRD (Substance Related Disorder) clients (Medicaid and some uninsured) were served in FY24, with a corresponding expenditure of \$29,433,715. Compared to FY23, the client count experienced a 5% increase, while expenditures increased by 20%. The significant growth in expenditure was driven by the increased costs of SRD Partial Hospitalization, SRD Outpatient services, Intensive Outpatient services, SRD Labs, and SRD Opioid Maintenance Treatment services, indicating that more county clients received community-based Substance Related Disorder treatment services in lieu of ER or inpatient services to support their recovery in the community.
- Incarcerated individuals are 40 to 129 times more likely to die from a drug overdose compared to the general public, with most deaths occurring within two weeks of release from correctional facilities. The Montgomery County Department of Health and Human Services' Jail Addiction Services provided Narcan training to 58 inmates who were identified with opioid use in 2024 and ensured each inmate had a Narcan Kit upon release. The Department also served 137 clients in 2024 at the Jail Medication Assisted Treatment (MAT) Program, representing nearly double the number of clients served in 2023. This treatment of clients in jail is often a first-time introduction to clients of the gold standard of care for opioid use disorder. This program includes

assistance transitioning clients to the community for continued treatment in the county's outpatient MAT clinic or at a clinic near their residences.

Current or potential collaborations with AODAAC:

Greater coordination/alignment with the Overdose Prevention Team (OPT) and the Overdose Fatality Review Team (OFRT)

- o The OPT is required by the state to promote multidisciplinary collaboration to expand substance use-related supports. *OPT is* also *responsible for developing the local strategy to reduce overdoses* and hosting meetings to discuss updates. While OPT is mandated by the state and AODAAC is per county charter; and the bodies' required compositions are different; there is a clear connection in functions with AODAAC's mandate to provide guidance to County Executive and County Council to identify substance use prevention and treatment needs in Montgomery County and reviews the County's efforts to address those needs; as identification of prevention and treatment needs informs local strategy and recommendations for use of funds, and both entities have a role in receiving updates on and reviewing efforts.
- O The OFRT reviews circumstances of individual fatal overdose cases, to identify safeguards to implement in systems of care to prevent future fatalities. Recommendations from OFRT findings should inform OPT in its local strategy development, and AODAAC's guidance in identification and review of needs.

ABS is wrapping up the Keeping it Safe Coalition for Under 21 Alcohol Use Prevention annual video contest for middle and high school students from public and private schools. We encourage anyone who knows a middle school or high schooler to invite them to submit a video. All entries are due by 4pm on March 31st.

We are looking at other ways to work with the SSL program to increase student participation and awareness. In addition, we will be conducting DUI focus groups that focus on the beliefs and behaviors towards alcohol among the Latino community. There is limited data on how beliefs, perceptions, and behaviors towards alcohol are seen by minorities.
