- **I. Welcome** The meeting was opened by Melissa Goemann, Co-Chair and Carlotta Woodward, Co-Chair of the Montgomery County Commission on Juvenile Justice (CJJ).
- II. Speaker: Shakirra Haynes, Senior Program Manager at DJS
 - Ms. Haynes spoke about the different units @ DJS Intake, Court/Waiver Investigations, and Probation
 - DJS processes for detaining youth in facilities, on monitors in the community or just providing services in the community
 - New laws on what juvenile court has jurisdiction over re: charging and detention
 - In terms of complaints about the current process in the system, Ms. Haynes stated there is a lot of time wasted in court, but also that court has complaints about time it takes to place youth
 - Ms. Haynes explained the process DJS has for placing youth once the court makes that order
 - She also explained that the department is understaffed and that there are not enough programs for mentoring, therapy, substance abuse available
