III. Chair Reports

- a. Subcommittee of Spring Forum Diane Lininger report
 - Daphne Klein and Denise Camp will be speaking about "From Stigma to Strength"
 - May 3rd at Bohrer Park in the gym at 6pm
 - Huge resource fair exhibitors let Diane know
 - Replaces MHAC meeting
 - Committee is meeting again on February 14th things are moving along
- March Speaker Tom Manion coming to speak on the Justice Center will provide an overview; Raymond Crowel will give overview of Strategic Alignment
- c. April Speaker Rita Deng will be speaker
- d. Budget Forums for the County
 - Monday was County Executive Leggett's budget forum for FY19; can go to montgomerycountymd.gov/open budget to see the slides and details of the forum
 - Josh Waters went through details there is a budget shortfall, due to uncertainty with tax revenue
 - Advocated for Mental Health Court
 - Diane no update on meeting for all chairs of Committees, Commissions, etc. with County Council HHS Committee; if anyone wants to go to this meeting, please let Diane know 3 to 4 people would be good; per Kiki timing is important; Diane to schedule the meeting after March 15th perhaps first week in April so we have enough time to tweak priorities as budget is being reviewed and passed over; Diane will let everyone know.

IV. BHCS Update – Raymond Crowel report

- FY18 savings plan \$4M was handed to HHS for cuts, County Executive trimmed that back by \$500k, partially by trimming back expansion of Mental Health Court only taking half of that cut so they can begin expansion in April
- "Watch" word for FY18 is delays in implementation of programs and hiring freeze (lapse
 – expand or shrink to meet the lapse) complete lockdown in terms of vacant positions;
 service gaps in Mental Health Court, Crisis Center, etc.; been on lockdown since early
 December and expect that to continue for the rest of this year
- Need to reduce capacity drug court, jail treatment center reduced by half; didn't significantly impact the provider community; CSA has several vacancies, which is slowing down their administrative processes including reporting and monitoring
- FY19 is still a work in process 2 3% reduction planned across the board in the County; plan is coming together in Exec's meetings and will be released March 15th; Council hearings are scheduled April 15th – May 15th
- Council will vote on the budget late May; not hearing much about State budget –
 diversion programming backlog for people in jails just waiting for transport up to state
 hospitals; capacity for beds at local and state levels is not meeting demand; state is
 looking for training opportunities for peers on substance use and mental health side

- MHAMD's annual legislative briefing is on February 7th in Annapolis from 4:30 7:30pm
- HHS sub-committee meeting dates have not been finalized, but will get them out to the committee when available – April 10th, 11th and 12th

Per Scott Davis – Maryland House Bill 111 – judges can now set dates for mandatory taking out of jail and taken to state hospital; DOCR and MCPD have endorsed it

V. Speaker: Dan Martin, Senior Director of Public Policy Mental Health Association of Maryland

MHAMD Legislative Briefing at Loews Hotel on February 7th at 4:30pm

About 3 weeks in for session – there's been a record number of bill requests – about 4,000 so far; Maryland Behavioral Health Coalition/MHAMD – hundreds of members statewide; came together really well over last couple of years on Keep the Door Open; this year the budget came out and said there was a 2% decrease rather than an increase for behavioral health providers – restoration of that cut is their #1 priority – legislature seems to be behind the restoration, so looking positive – it's approximately \$8M – they are pretty positive it will happen;

Priority #2: Expanding crisis treatment and telehealth across the state – highlighting model systems across the state; so the Coalition settled on a plan and drafted legislation which dropped in the Senate and the House which will create a grant program where local jurisdictions can apply to expand their crisis response systems – proposals will require support for substance use and mental health for all populations, will give priority for blended funding systems – State shouldn't be the only partner; Coalition is working with the administration to get something going this year; however message is not an either or – we need crisis support and rate increases to help support for maintenance purposes – go together very closely

Priority #3: Improving quality and outcomes of behavioral health services in primary care settings – because people don't see good results, no follow-up; Coalition is pushing for a bill which will require a pilot program for a collaborative delivery system – proven to improve services and save money; no matter where they are, people are getting good behavioral health services; bill will go in and then conversations will begin

Rate increases – have heard from legislators that the HOPE Act wouldn't have gone through if it wasn't for the state-wide support and rally – it gives the momentum necessary to get the bill passed; help promote the rally on February 22nd; per Jennifer we sent a letter of support last year for the HOPE Act – perhaps we can write another letter to support restoring the 2% cut; we will need a formal motion when the letter is drafted; Raymond – this was designed to close the gap for mental health providers, so this cut is very disappointing; per Dan – providers are having to close their doors, which is very discouraging;

Dan – MHAMD has been working to implement the parity law; data is bleak for Maryland – in 2013 nationally people were more likely to go out of network for behavioral healthcare – stats got worse in Maryland every year – third worst in the nation; network adequacy

Seeing kids stuck in ED's – hearing lots of anecdotal stories – a bill will be introduced around data transparency to corroborate the anecdotal stories; TCM hasn't been as effective or utilized as anticipated – good news is that rates for TCM were increased

House Bill 111 – MHAMD did not take a position on this bill because they see both sides of the issue – don't want people waiting in jails for a bed – numbers are down; House Bill 385 is an alternative bill – has some problems

Raymond – challenge in County is residential rehab beds – and people waiting on beds – state controls the expansion of beds – and has said no to MoCo for last 7 – 10 years; per Dan – crisis bill they are putting in includes crisis residential beds and residential rehab beds to help address this

Jeanette – could class action lawsuits get filed against insurance companies that are not following parity law; but parity violations are very hard to prove

Raymond mentioned House Bill 499 – involuntary commitment/EP for someone who has overdosed; MHAMD's position is they are not the experts on SUD's

CIT Coordinators – 2nd annual conference in Ocean City is planned

MHAMD Advocacy page – they send out weekly updates during session

Springfield Hospital Update – Debbie's report

Central admissions are up and running – still a work in progress – there's only 1 person on the waiting list from MoCo; they continue to bring people in as they discharge people; they are at census now
