- Budget Priorities Garrett attended annual meeting with Health and Human Services Committee of the County Council on October 17, 2019.
- Budget Hearings K. Curran went to one of the County executives budget hearings. K discussed the County executives plan to make budget a two year process that meets the "Turn the Curve" initiative. Diane will email everyone the link to the County Executives plan. K. discussed that the "Turn the Curve" initiative discusses Early Childhood, affordable housing, climate change, White Flint metro stop and a 10 year plan.

- Mobile Crisis team Garrett stated that they had met and come up with a list of potential speakers that will be forwarded to Diane to contact. They are also working on a white paper identifying the problems that exist in the County and why they need to expand the team.
