## ABOUT US

Montgomery County Trauma Services is a comprehensive center for survivors of domestic and intimate partner violence and their children and survivors of crime including sexual assault/rape, physical assault, homicide, human trafficking, etc. The program provides coordinated wraparound support for survivors.

## WHO IS ELIGIBLE?

Montgomery County residents who are survivors of domestic and intimate partner violence and their children, survivors of crimes including rape/sexual assault, homicide (surviving family and friends), physical assault, human trafficking, etc., offenders of intimate partner violence, survivor's family, and significant others, and/or survivors of violence and crimes which were committed in Montgomery County.



## AVAILABLE SERVICES

- 24/7 telephone and walk-in crisis counseling, information, and referral.
- 24/7 Outreach Services at hospitals and police stations, including support and accompaniment during medical exams and reporting to the police (upon survivor's request).
- Emergency assistance to meet immediate needs such as food, shelter, and clothing.
- Emergency Domestic Violence Shelter Placement.
- Safety Planning.
- Individual counseling services for survivors.
- Support and/or educational groups for survivors.
- Support and/or educational groups for family and friends of survivors.
- Individual child/adolescent counseling services for those who experienced violence in the community.
- Assistance with filing for peace and protective orders, filing criminal charges and writing victim impact statements.
- Victim assistant services including:
  - \*Assistance with navigating the criminal justice system
  - \*Court Accompaniment and support
  - \*Filing criminal chargers
  - \*Completing victim impact statements
  - \*Collaboration with police, State's Attorney's Office, and other County agencies (upon survivor's request).

- Anonymous third-party reporting of sexual assault/rape to the Montgomery County Police Department (upon survivor's request).
- Case Management Services including referrals and linkages to community providers and eligible services.
- Psychiatric evaluation, treatment, and consultation.
- Compensation for income eligible survivors from the Montgomery County Crime Victims Compensation Fund.
- Assistance in applying to the Maryland Criminal Injuries Compensation Board (CICB).
- Victims' rights education.
- Community education on victim advocacy/rights, sexual assault/rape, domestic and intimate partner violence, human trafficking and crime prevention for professionals and community groups.
- Abuse Intervention Program - Treatment for intimate partner violence offenders.
