II. Roll Call & Virtual Meeting Procedures- Neda Bolourian

III. Approval of Minutes from Past Meetings- Neda Bolourian

• The minutes were approved due to quorum.

IV. New Liaison Introduction and Spotlight-Brian, Kathryn, Rosalia and Linda

- Brian Koosed introduces Rosalia Scotman as the new liaison replacing Rafiah Prince.
- Rosalia Scotman speaks of how Trauma Services serves individuals who are survivors of general crime, domestic violence, sexual assault and that they provide therapeutic services, housing assistance and victim advocacy.
- Linda Lochner states that the victim advocates are state certified and will be getting national certification, and that a huge component of program is the therapeutic services from children to the elderly dealing with diverse crimes such as cyber-crime, stalking, harassment, and assault to elder abuse. Together with programs like the County funded compensation fund. Since 1999, the fund reimburses survivors of crime up to \$2,500 for lost wages, medical co-pay, and funeral expenses. This fund is looking to possibly increase to \$5,000.
- Brian Koosed will attend the ICH meeting next week Wednesday August 2, 2023, at Rockville Memorial Library about housing and how they overlap with our initiatives and advocate victim housing.
- Brian Koosed explained to the board members about the executive subcommittee meetings with County Council and County Executive and about advocating trauma services needs and that the meetings are winding down and will restart in December-March.

V. Executive Subcommittee Update- Brian

- Kathryn Pontzer updates the board members about yesterday's Criminal Justice Coordination Commission meeting.
- The new changes to State law about disciplinary action in police complaints and how it affects County laws and how some jurisdictions are adapting to the new laws.
- The County will communicate better with the public, how to get information out publicly through outlets like Facebook and using listening tours.
- Earl Stoddard from the County office is the liaison to the Criminal Justice Coordination Commission and asked about sub-committee structures; Judge Bonifant spoke about capacity and mental health issues; John McCarthy wants a subcommittee on juvenile crime. Department of Corrections spoke about improvements in rehabilitation and reentry; Sheriff's Office spoke of staffing, domestic violence policies.
- Challenges about limiting interrogation times, police shootings, marijuana laws, impaired driving, auto theft, etc.

- Kathryn Pontzer no updates on Legislative Subcommittee which will again start in September.
- Mentioned to new board members if they want orientation later.
