- The Criminal Justice Coordinating Commission meeting was in person on May 24th, 2023.
- During the Criminal Justice Coordinating Commission meeting members voted for a representative to be on the human trafficking prevention committee.
- Penalty for the Gun crime Bill state law has changed from 3 to 5 years first time offense.
- Gun ownership laws were discussed.
- Licensing requirements for gun ownership has changed.
- A bill holds parents accountable for access to guns in children.
- Better structure of laws for selling cannabis and driving while intoxicated.
- There is a gap in our system for juveniles who are committing felonies.
- Perpetrators are not being accountable for surrender guns.
- Juvenile crime has increased.
- Guns not being confiscated by police officers without a warrant.

- Victim Services Advisory Board members attended the Board and commission meeting "Meet and Greet Event".
- Board members met with other county members, and councilmembers Gabe Albornoz and Sidney Katz.

- Bill SB 27 Criminal Procedure Restorative Justice Program -this bill did not make it out of committee - much opposition - not victim-centered enough/need more safeguards MCASA, MNADV, HOR opposed, but University Of MD Law School Gender Violence Clinic supports bill.
- Bill SB 615 Governor's Office of Crime Prevention, Youth, and Victim Services Sexual Assault Evidence Collection Kit Reporting Program passed.
- Bill SB 789 / HB 758 Sexual Assault Evidence Collection Kits Preservation and Storage passed.
