Review and Discuss:

Provide feedback to the County Council and County Executive on both the Early Care & Education Initiative (ECEI) Action Plan and Montgomery Moving Forward's "Roadmap for Developing a Public-Private ECE Coordinating Entity" in an effort to support the County's child care system response and recovery with a specific focus on equity and operational recovery.

Work Plan Draft Proposal: We drew from Year 2 priorities from Montgomery County Early Care & Education Initiative Action Plan 2020 and will also draw from MMF's proposed models.

- Sustainability:
- Reduce costs of training and professional development for early educators
- Access and Affordability:
 - Review the Working Parents Assistance Program (WPA) need and usage, align eligibility rates with the State Child Care Scholarship (CCS) (subsidy) and streamline the application process. Reformulate WPA process and usage and examine WPA funding for "seats", creating contracts with early education programs.
 - Expand WPA and provide more families with child care subsidy supports by improving access to families within 350% of Federal Poverty Level (FPL) and then incrementally increasing the income eligibility.

- Use State CCS and WPA to subsidize costs for low-income parents to fill Child Care in Public Space (CCIPS) vacancies.
- Develop a public awareness campaign in multiple languages to fill and sustain vacant slots in child care programs: center-based and family child care through utilizing WPA funding and additional funding
- Alignment:
 - Align Montgomery County Public Schools (MCPS), Child Care in Public Space (DHHS) and Community Use of Public Facilities (CUPF) child care application, selection and re-bid processes.

Process: (L'Ornya to lead and Sybil to keep time)

- (5 mins) Read: Look at the ECEI action plan goals that were selected (above)
- (3 mins) Introduce: The above are our proposed aligned goals from the ECEI action plan. They
 represent the activities for FY 2021 that the County will move to action on, and the CCC can
 work to support these goals by providing stakeholder perspective, sharing additional information,
 or developing guidance or recommendations (or other activities as deemed valuable by the CCC)
- (4 minutes) Discuss: How are these consistent with our priorities and last year's recommendations? How do they line up with what we know is important for COVID recovery, for equity, for other considerations?
- (24 minutes (6 mins each)): What are the most important next steps for the CCC to know, how can we find out more about what the County is doing RE: implementation, what are strategies and tactics that may be MOST helpful or IMPORTANT for our work around this goal? Who can and will lead us around our action on this goal?
- (4 mins) Reflection: What do we still need to do, what's left so that we can be in "action mode" as soon as 2021 is here?
