Meeting Called to Order: Michelle Belski, Vice Chair, called the meeting to order at 6:10 p.m.

Welcome and Introduction of Guests

Commission Business

- **Build Slate for April Election of Chair and Vice Chair**
 - Current Nominations: Michelle Belski, Chair

- **Annual Planning Retreat:** Tentative Plans

- **Feedback from CCC's Meeting with Councilmember Alborno**

- Commissioners Michelle Belski and Laura Seminario-Thornton and HHS staff (Erin Stillwell) met with Councilmember Alborno and senior legislative assistant, Beth Shuman, on March 20th
- Discussed ECE Initiative, public space rebid process, and lack of adequate affordable child care in Montgomery County
- Councilmember Alborno recommended that CCC show No Small Matter movie in lobby of COB and use this as an opportunity for public awareness around issues involving early care and education
- **Discussion on County's FY20 Budget and Early Care and Education Initiative** (overview provided by JoAnn Barnes)
 - ECE Initiative was a fast-paced initiative; stemmed from Council President Navarro's desire for a 4 year initiative
 - Looking at the First Year (first 100 days of administration); first year begins March 1, 2019 and ends February 2020 (planning for 2nd, 3rd, and 4th year will happen during the first year)
 - Workgroups will be led by Bibi Otero from CE's Office
 - **Budget:** Reduction of 3.2 million dollars; reduction came out of WPA budget due to changes made with the State scholarship programs
 - 7 million dollars (for first year)
 - Net increase to Early Care 3.8 Million
 - Money has been moved into a non-departmental account to be spent on Early Care and Education. Possible examples of spending:
 - Looking to spend this funding on targeted groups (ex. Subsidizing child care for a child who is in Head Start)
 - Support Early Child Care Centers via MCPS
 - Additional funds for Early Childhood Mental Health
 - Additional funds for Child Care in Public Space
 - Looking at raising the rates of WPA
 - Looking at ways to retain currently licensed providers
 - **Concerns of the CCC:**
 - These funds are not specifically earmarked for WPA; families need additional funds (beyond what is provided by the State Scholarship program) to afford quality child care
 - Concerns about expanding the number of seats by recruiting new providers; but current already established centers and family child care centers have open slots, but families cannot afford the care

Updates:

- **CUPF (Bill Polman):**
 - Working with MCPS and CE to look at new rebid process protocol

- Bill is working on a benchmark study to look at programs (if you are aware of an outstanding program model, please share with Bill)
- **ECCC (Michelle Belski & Rosalba Bonilla Acosta):**
 - Today's meeting was focused on budget discussion
 - Barbara also presented the Regional Network Stakeholder Engagement
- **State Updates (Monica Ortiz):**
 - Ready by 5 Town Hall (Monica will send invitation)
 - May 17th (am session and pm session)
 - Free, but must register
- **WPA/State Scholarship Program (Yvonne Iscandari):**
 - WPA current caseload is 43 families/67 children
 - OESS is currently waiting for the report from the State regarding supplements for children 0-8
