  - Commissioners discussed possible topics to include in the letter (learning recovery, issues identified with virtual learning, encouraging MCPS to look outside the County for best practices, acknowledging the hard work and commitment of MCPS staff to the students during virtual learning, issues with virtual learning and student with individual learning needs, how to assist families with limited access to technology, student frustration using various types of learning platforms, mental health of students, staff and families, etc.).
  - Address letter to Board of Education and cc to other identified stakeholders
  - $\circ~$  Have working draft of letter ready to distribute to full CCY prior to June  $10^{th}$  meeting
