AAA Director updates- Dr. Patrice McGhee, Director Area Agencies on Aging

- The staff is in the process of drafting the area plan update which is due May 31. Federal monitoring of Titles III and Title VII of the Older Americans Act for 2020 and 2021 prereport due June 1. Final report due July 26. Will provide the draft plan to Barbara for review and approval.
 - Federal monitoring Titles III and Title VII for 2020 and 2021 pre-report due June 1 final report July 6.
 - Staffing: Vacant positions; Caregiver Manager, one full-time Ombudsman position in budget (which converted from being a half-time Ombudsman position), two nurse positions vacant.
 - May is older Americans Month. Tthe theme is "Age My Way ", to honor them on May 19, the County Executive held an in-person Proclamation Event. Odile, Patrice, Shawn, and Barbara attended the event. Dr. McGhee thanked Barbara for her beautiful remarks. Then she read The Older Americans Month Proclamation to the group.
 - Senior Planet Tech Hotline support hours were extended to 9am-8 pm, Mon-Fri, 888.713.3495
 - Talked about OHCQ, that conducts inspections of nursing homes in Maryland. Tier I must be done before Tier II. Because of covid and ransomware, the state of Maryland has a backlog of inspections.
 - Responses to Questions: Dr. Mc Ghee: the inspections are monitored by the state of Maryland. The age in the Older Americans Act is sixty and older (not fifty), except possibly employment programs

Presentation on Building Bridges: Improving Cultural competency with Asian Americans-Phoebe Shih, Asian American Health Program

- Asian American Health Initiative (AAHI) is dedicated to improving the health and wellness of Asian American communities in Montgomery County by applying an equity lens, community engagement and data driven approaches. AAHI was established in 2005 as part of Montgomery County Department of Health and Human Services, under the Office of Community Affairs.
- Montgomery has diverse groups of many Asian cultures such as Chinese, Korean, Vietnamese, Pakistani, Indian, Japanese, Pacific Islanders and East Asia and Southeast Asia, to name a few. AAHI disseminates relevant health information to the Asian American community at faith-based and community-based organizations, cultural events, health fairs and small businesses. AHHI's culturally and linguistically tailored health education materials are available in multiple languages. Montgomery County has large populations of Asian Americans who live in Gaithersburg, Rockville, and Parkview.
- AAHI also provides referrals to screening and health care services throughout Montgomery County to eligible residents. To support and empower community partners in the Asian American community, AAHI provides several types of workshops to local organizations so that communities have the skills, knowledge, and resources to better address the needs of their members. Some of the health concerns such cancer, hepatitis B, diabetes, tobacco, use and osteoporosis.
- Project and the Public Resource Education Program (PREP): AAHI also provides technical assistance to community partners and public Health Organization to support the planning, implementation and evaluation of their health services and programs. AAHI offers insight on best practices and community outreach and health programs implemented in Asian American communities. Equipped with these tools, organizations can be more effective in addressing the health needs in their communities and be able to develop programs and services that are culturally and linguistically competent when serving Asian American.
