Revised Committee Missions

Aging in Place/Community Committee

- Begin development of a public and private transportation and mobility system that is responsive to the needs of older adults in the County.
- Monitor the progress being made by the Housing and Planning Departments in changing County policies so that seniors have greater choices in dwelling types and to recommend action by the COA as needed and appropriate.
- Monitor progress on overall approach to needs of groups/entities concerned with Aging in Place.

Communications and Community Outreach Committee

- Advises the Commission on recommendations to County government offices and the Senior Subcabinet about providing education and information to County residents on County programs and services for seniors.
- Collaborates with other Commission committees to identify communication needs of County seniors, develop communication messages, and propose communication approaches.
