About Lori Garibay-Aquino:

Lori Garibay-Aquino is the Chief of Children Youth and Family Services within DHHS. Her portfolio includes oversight and advocacy for several programs which include, Early Childhood Services (ECS), Community & Youth Violence Prevention and Intervention (CYVPI) program, Community Action Agency (CAA), the Lighthouse program and several county-wide initiatives including the Youth Resilience Initiative.

Lori joined the County under 2 years ago as the Deputy Chief and soon became Chief. Before coming to the county she worked at the District of Columbia Department of Health. She is a passionate advocate for health equity, dedicated to improving healthcare outcomes for diverse and underserved populations. Lori’s work has consistently focused on integrating epidemiological research with community-based interventions, ensuring that health policies and programs are inclusive and equitable.
