#### Commission on Health FY21 Annual Report

The Commission on Health (COH) respectfully submits its Fiscal Year (FY) 2021 Annual Report. Working both with the County's leadership as well as the dedicated, professional and conscientious staff of the Department of Health and Human Services (DHHS), the COH focused on key public health issues. The COH also provided recommendations to county leadership and DHHS staff on improving county resident health and well-being.

In FY21, the COH focused on communicable disease, school health, racial equity and public health data and modernization. The COH explored topics related to Healthy Montgomery metrics, reports on health equity and other county data, and staff needs and capacity.

Following the onset of the COVID-19 pandemic, the focus of the COH changed dramatically as the pandemic brought the existence of health disparities in Montgomery County to the forefront. The pandemic reinforced the need for additional epidemiological resources within the County to support data analysis and reporting. The COH formed a Public Health Data and Modernization workgroup to strengthen data collection, analysis, and dissemination. The workgroup explored topics related to Healthy Montgomery metrics, reports on health equity and other county data, and staff needs and capacity. In FY22, the COH hopes to continue its efforts with the addition of cross cutting priorities that are geared towards tackling equity in health.

It has been an honor to serve as the chair of the COH during FY21. The Commission is filled with 19 dedicated and very accomplished professionals who willingly volunteer their time and knowledge to leave a lasting positive effect on DHHS and Montgomery County Residents. The Commission also benefits from the expertise of ex-officio DHHS members, support from DHHS staff and liaisons from other commissions. The COH respectfully submits the attached FY21 Annual Report and looks forward to continued work and collaboration to improve public health and advise the County Council and County Executive.

## **Mission and Purpose**

The primary mission of the Montgomery County Commission on Health (COH) is to advise the County Executive and the County Council on public health issues, programs, services and the allocation of funds devoted to public health needs and to monitor and assess the priorities of the Montgomery County Department of Health and Human Services (MCDHHS) in its efforts to address the health needs of residents in this County. The purpose of this report is to comply with the annual requirement that the COH provide the County Executive and the County Council with an update on the activities of the COH from July 2020 through June 2021.

#### **Structure**

The Commission is comprised of 19 voting members with representation from consumers and providers of health services in the County. As dictated by County Code, the COH also has a representative from the Montgomery County Medical Society. In FY21, there were 11 consumers, and 8 providers, including the Medical Society representative. The ex officio (non-voting) members of the COH include: the County Health Officer; the Montgomery County Public Schools liaison; and the County Council liaison. The COH continues to represent a diverse cross-section of Montgomery County residents.

Membership consisted of 19 members who were racially and ethnically diverse and vary in age, gender, geography and experience in health policy, public health, and the health care system.

The COH Chair and Vice Chair are elected by COH members and serve one-year terms. During FY21 Desiree de la Torre was the Chair of the Commission and Christopher Burt was the Vice Chair.

## **Meetings**

The COH meets at 6 p.m. on the third Thursday of the month (except in August) at 401 Hungerford Drive, Rockville, MD 20850. All meetings are open to the general public. Due to the COVID-19 pandemic, the COH met monthly via the virtual meeting platform Zoom for the entire FY21 including a meeting in August. COH members voted to meet in August due to missed meetings in April and May of 2020.

At a minimum, every member of the Commission is expected to either serve on one workgroup and, when possible, as a liaison to other health-related County boards, commissions, committees or minority health initiatives and programs.

With its broad perspective of public health, the COH recognizes the value of collaboration and communication with other health-related boards, commissions and committees. Many commissioners have an area of specialization, interest or constituency of public health and are therefore encouraged to serve as liaisons with other relevant health-related boards, commissions and committees (BCCs). Integral to this area of special interest is the constraint that all actions are in voice of the entire COH and not self-serving in any manner. Finally, members of the COH also served on committees that allowed the COH to conduct its business such as the membership, nominating and retreat planning committees. These committees require significant time and are in addition to the monthly scheduled meetings.

## **Commission on Health Workgroups Summary Reports**

#### **Communicable Disease**

The Communicable Disease workgroup sought collaboration with other COH work groups, primarily School Health, looking for areas of mutual interest to help prevent communicable diseases. The specific area of interest area identified was improving immunization rates by spreading awareness on vaccines, supporting initiatives to address vaccine hesitancy and encouraging utilization of mobile vaccination vans. In January members of the two workgroups spearheaded a letter to the County Executive and County Council with recommendations on equitable vaccine distribution.

The pandemic has reinforced the existence of health disparities in Montgomery County, and while all can benefit from routine immunizations, reducing cultural, language, and other barriers to recommended vaccinations is essential to promote equity. The workgroup also penned a letter to the County Executive in support of the County's continued COVID-19 restrictions.

The workgroup also investigated gaps in health services for HIV, TB and STI prevention. They met with individuals within the County to gain an understanding of resources, funding and staffing currently available. As the focus turns away from COVID-19 in FY22, they hope to learn more about the health needs and service gaps related to these communicable diseases. They will continue to encourage focus on science-based approaches to preventing communicable diseases, with particular attention on HIV, TB and STI prevention.

## **Commission on Health Workgroups Summary Reports (Cont.)**

#### Governance

The Governance Workgroup was formed in January 2020 to strengthen the operations of the COH. During the past year, the workgroup's efforts were informed by a survey of new members. This informed changes to information that was shared during the orientation of new COH members, as well as to updates on the website and the Microsoft Teams site. In addition, the Workgroup developed a guidance document on establishing and managing COH workgroup priorities.

To better understand the needs of COH members and to support succession planning for Commission leadership, the workgroup also conducted one-on-one discussions with each Commissioner. These discussions yielded suggestions related to bolstering the toolbox that workgroups can use to effect change, as well as to identifying more opportunities for Commissioners to get to know each other.

#### **Public Health Data and Modernization**

The Public Health Data and Modernization was formed in November 2020 to strengthen data collection, analysis, and dissemination. The workgroup has explored topics related to Healthy Montgomery metrics, reports on health equity and other county data, and staff needs and capacity. Through discussion with several members of DHHS' Planning and Epidemiology team, the workgroup identified the need for greater department staffing capacity to compile and track administrative and clinical data from the Healthcare for the Uninsured program.

In the next fiscal year, the workgroup will coordinate with the Montgomery Cares Advisory Board on a specific request related to this critical need. In addition, the workgroup will review forthcoming recommendations from the National Commission to Transform Public Health Data Systems and endorse specific recommendations relevant to DHHS.

#### **Racial Equity**

The racial equity workgroup was established during the in November of 2020 with the goal of promoting equitable access to health services within the County. Their goals were to support vaccine education, ensure access to COVID-vaccine and improve testing in high risk and marginalized communities.

The workgroup sought collaboration from both the School Health and Communicable disease workgroup to align efforts. The workgroup investigated ways to ensure a safe return to school for students. They also researched potential barriers that prohibited students returning to school due to equity.

## **Commission on Health Workgroups Summary Reports**

#### **School Health**

Following an active year with the School Health Workgroup where County Council advocacy helped secure additional funding for School Health Nurses to better meet the needs of Montgomery County Public Schools students. This fiscal year focused on oversight and raising awareness for school health needs following the Covid-19 Pandemic school closures.

The School Health Workgroup hosted Joan Glick of the DHHS School Health Services division at the October general Commission on Health meeting, to hear an update on school health services, personnel, and plans for possible reopening of school health centers, clinics, and health rooms when allowed. While schools remain closed, almost all School Health staff have been reassigned for a large portion of their time to cover other public health department needs. Certain portions of the staff time remain allocated to school health needs, including follow-up for enrolling families needing to update vaccines. The Commission was assured that when schools are allowed to reopen, school health staff will be able to return to their school assignments. Attainment of adequate PPE, safety measures, and other planning information was shared, and DHHS is working hard to assure high levels of safety can be assured when schools are allowed to reopen.

The School Health Workgroup engaged in conversation for the remainder of the year around 3 major issues: assuring the safety of students and staff when schools are allowed to reopen; considering ways schools can play a role in reversing the downward vaccine rates, as a result of Covide-19; and begin to consider the important role schools play in children's mental health.
