On behalf of the Commission on Health (COH), it has been a privilege to have spent this past year working together with our elected officials and esteemed colleagues in Montgomery County Department of Health and Human Services (MCDHHS) and specifically Public Health Services (PHS). Our work together has afforded us the opportunity to continue our focus on key public health issues impacting the health and wellbeing of Montgomery County residents. This fiscal year the COH theme was "Getting Back to Basics" which signifies our goal of realigning COH activities and strategies to intensify the impact of our advocacy efforts. The COH FY23 Priorities included Access to Care, Environmental Health Education and Public Health Administration. The Commission also took advantage of the opportunity to advocate for the need to strengthen our public health workforce.

The COH continues to advocate for improved access to healthcare in the County. We recommended innovative strategies and programming be used to increase public health services and meet the growing needs of the community including the equitable distribution of services throughout the County, particularly to high need areas. In an effort to raise awareness about common environmental threats, the Commission urged County leaders to increase public health education on the topic using a variety of communication and social marketing strategies. The COH persists in our advocacy to increase the County's data handling capacity. This advocacy effort was put forth through the Public Health Administration priority that in addition to increasing human resource capacity recommended better use of data to improve program evaluation, facilitate the efficient use of resources, inform decision-making and increase service quality.

The COH respectfully submits the FY23 Annual Report. We hope that it provides you with a glimpse into the work of the Commission. As chair, I have been fortunate to work with a diverse group of professionals, who have selflessly volunteered to be part of this important work. They, in addition to the consummate MCDHHS staff and leadership have enabled this work to go forth. I would be remiss if I did not extend my thanks to the generosity of the ex-officio County Executive and County Council representatives and the Public Health Services department heads who took the time to present about the critical work their departments do. The COH looks forward to our continued work collaborating with and advising the County Executive and County Council as we work together to improve public health in Montgomery County.

Mission and Purpose

The primary mission of the Montgomery County Commission on Health (COH) is to advise the County Executive and the County Council on public health issues, programs, services and the allocation of funds devoted to public health needs and to monitor and assess the priorities of the Montgomery County Department of Health and Human Services (MCDHHS) in its efforts to address the health needs of residents in this County. The purpose of this report is to comply with the annual requirement that the COH provide the County Executive and the County Council with an update on the activities of the COH from July 2022 through June 2023.

County Code Enabling Legislation Sec. 24-24. Functions

To advise the County Executive and the County Council, the Commission must:

- 1. Periodically review available County public health programs, services, and facilities;
- 2. Comment on gaps, deficiencies, or duplication in County public health programs, services, and facilities;
- 3. Report each year to the County Executive on the performance of DHHS public health programs, actions needed to improve the programs, and the priorities within which the improvements should be made;
- 4. Comment on the proposed allocation of funds to County public health programs in accordance with the Department's priorities, considering the available financial resources and the need for health cost containment;
- 5. Advise on local public health planning needs;
- 6. Comment on the appropriateness of institutional health services proposed to be offered in the County and the metropolitan area by the private sector and nonprofit, state, or other public sector agencies;
- 7. Advise on the development of statewide criteria and standards for certificates of need and health planning, considering the regional impact when appropriate.
- 8. The Commission must report to and meet with the County Council, sitting as the County Board of Health, at least annually, on the programs and policies within its purview.

Structure

The Commission is comprised of 19 voting members with representation from consumers and providers of health services in the County. As dictated by County Code, the COH also has a representative from the Montgomery County Medical Society. In accordance with County Code the majority of the 19 commissioners were consumers with the balance being providers, including the Medical Society representative. The ex officio (non-voting) members of the COH include the County Health Officer and the County Council liaison. The COH continues to represent a diverse cross-section of Montgomery County residents.

Membership consisted of 16 members who were racially and ethnically diverse and vary in age, gender, geography and experience in health policy, public health, and the health care system.

The COH Chair and Vice Chair are elected by COH members and serve one-year terms. During FY23 Dr. Crystal DeVance- Wilson was the Chair of the Commission and Susan Emery was the Vice Chair.



Meetings

The COH meets at 6 p.m. on the third Thursday of the month (except in August). All meetings are open to the public. The COH met monthly via the virtual meeting platform Zoom during the 2023 fiscal year. The COH had one hybrid meeting, offering both in-person and virtual attendance, for the retreat September 15th 2022.

At a minimum, every member of the Commission is expected to either serve on one workgroup and, when possible, as a liaison to other health-related County boards, commissions, committees or minority health initiatives and programs.

With its broad perspective of public health, the COH recognizes the value of collaboration and communication with other health-related boards, commissions and committees. Many commissioners have an area of specialization, interest or constituency of public health and are therefore encouraged to serve as liaisons with other relevant health-related boards, commissions and committees (BCCs). Integral to this area of special interest is the constraint that all actions are in voice of the entire COH and not self-serving in any manner. Finally, members of the COH also served on committees that allowed the COH to conduct its business such as the membership, nominating and retreat planning committees. These committees require significant time and are in addition to the monthly scheduled meetings.

Commission on Health Workgroups Summary Reports

Access to Care

The Access to Care Workgroup was formed at the September 2022 COH Annual retreat to support increasing access to care to meet the health needs of all residents more completely. The workgroup advocated for the following five priorities:

- Growing the Healthcare Workforce to include underrepresented populations.
- Increasing quantity and quality of Healthcare Providers who accept Medicaid patients.
- Feasibility study for free standing public health clinics in Psychiatric/Mental Health, Perinatal (Obstetrics, Pediatric) and Geriatric care in underserved communities
- Public Relations Campaign to advertise existing initiatives and to promote recruitment, retention, and utilization of existing services of, for and by underserved communities.
- Ensure adequate access to produce "food is Medicine" by including weekday produce markets in areas designated as food deserts.

This workgroup shared their advocacy letter with the County Executive in December 2022 and with County Council in March 2023.

Environmental Health and Education

In 2022, Montgomery County Commission created the Environmental Health Working Group to focus new light on the intersection of environmental and public health. Work Group members met with two of our sister Commissions: the Climate, Energy, and Air Quality Advisory Commission and the Water Quality Advisory Group, as well as with the Montgomery County Health Department to

find synergies across our work as commissions. Our efforts focused on reviewing each Commissions' goals and objectives for 2022, to begin assessing, evaluating, and analyzing alignments that could potentially lead to collaborative efforts to mitigate climate change and its impacts on Montgomery County residents' health, thereby increasing community resilience.

To that effect, in December 2022, the Health Commission – on behalf of the Environmental Health Working Group - submitted several recommendations to County Executive Mark Ehrlich. To mitigate potential harm to County residents, the COH recommends the following actions be taken to raise awareness about environmental threats in Montgomery County, which include Temperature-Related death and illness; Extreme weather events, Air quality and water-related illness: Food safety and distribution; and Mental health and well-being.:

- Invest in establishing a dedicated environmental health workforce to include appropriate training to recognize and address the health impacts of environmental health threats.
- Assess the environmental health risks in Montgomery County using well established tools like the Maryland Environmental Screening Tool developed by the Center for Community Engagement, Environmental Justice, and Health (CEEJH) to identify sources of threats, prioritize communities at risk, and assess resource needs.
- Consider aligning activities, to the extent possible, with the Healthy People 2030 Environmental Health Objectives. These objectives are established using reliable measures and with the input of experts from across the country.
- Form strong and diverse partnerships which are key to helping our communities better understand and respond to environmental risk factors. Bringing together the combined experience, skills and resources of County government, community-based organizations, public health professionals, health care providers, and academic institutions to develop a comprehensive approach to a dissemination strategy that would reach all residents.

Public Health Administration

The Public Health Administration workgroup of the Montgomery County Commission on Health (COH) identified advocacy as a key priority for 2023. They recognized the critical role of data in achieving fiscal accountability and emphasized its utilization to demonstrate the efficient use of funds. The workgroup prioritized data evaluation, management, analysis, and communication to inform decision-making processes and effectively address the county's evolving needs. They underscored the importance of making client data accessible, integrating existing data pockets, and establishing robust evaluation programs. Through their advocacy efforts, the Public Health Administration workgroup aimed to improve fiscal accountability, advocate for effective funding allocation, engage stakeholders, enhance data management practices, and ensure the long-term sustainability of programs targeting chronic diseases and community health.
