3.0 Age Friendly Montgomery Presentation – Marcia Pruzan

- Age Friendly Montgomery is a global initiative in 20 nations and more than 180 communities across the US.
- AARP is the umbrella organization in the US.
- The mission is to encourage states, cities, towns, and counties to prepare for the rapidly aging population by paying increased attention to the environmental, economic, and social factors that influence the health and well-being of older adults.
- The vision is, "Montgomery County: a wonderfully diverse Community for a Lifetime," where all residents can remain and thrive as they age and be a powerful resource in making our County a better, stronger, more inclusive community for everyone.
- Top concerns of older residents are improved communications about the county programs and services for all seniors, including those in our ethnically diverse communities, transportation, and ability to remain in the community in retirement.
- At the 2015 Summit on Aging the topics worked on included:
 - > Expanding transportation and senior centers;
 - Expanded the village concept, helping seniors age in place;
 - Established the 7-3000 line for seniors;

- Fire department and EMS staff working with seniors to keep them out of the hospitals; and,
- > Dementia Friendly America, helping families function in the community.
- COH can help by:
 - ➤ Consider areas where COH priorities and Age-Friendly intersect;
 - ➤ Inform Age-Friendly and Commission on Aging of areas of mutual interest and potential collaboration; and,
 - > Considering COH initiatives and recommendations;
 - ➤ Participate in and/or support Age-Friendly work where interests intersect.

4.0 Chief's Report – Dr. Travis Gayles

The Chief's Report for October 2017 is attached to these minutes. A few highlights discussed included the following.

- Eight persons required Post Exposure Prophylaxis following exposure to a confirmed rabid cat in the White Flint area.
- The drug "PrEP" is now being offered to prevent HIV transmission. Most insurances will cover this. A possible side effect is problems with the kidney function, mandating that lab tests be done every three months.

5.0 Liaison Reports:

Children, Youth, and Families – Brenda Brooks

- The annual report contains information on the work being done on opioid use.
- There are mental health concerns for children of all ages.

6.0 New Business:

- Workgroups for the year were decided upon. They include:
 - ➤ Men's Health Data was gathered last year, as well as information on other counties approach to men's health.

 - ➤ Behavioral Health Focus on mental health and adolescences between the ages of 16 and 24; shortage of mental health experts and beds; stigma; bullying; and promoting mental wellbeing. Group members: Brandi Armijo, Lenna Israbian-Jamgochian, Jacqueline Smith, and Desiree de la Torre.
 - ➤ Access to Contraception Access in schools. Group members: Heather Deckert and Jason Woo.
- November 28th COH will be meeting with the County Council to give this year's priorities.
