- c. Health Officer's Report (provided at the end of the meeting)- Dr. Davis
 - Welcomed new members and highlighted their expertise as residents in the County and their ability to help spread word on what exists and help inform on where the gaps are.
 - ii. The importance of prevention and how to rethink health moving forward. The importance of building communities that promote health.
 - iii. Respiratory Virus Update: COVID has been increasing with a late summer wave, trend not as high as last year. Flu vaccine recommendations have not changed; new Flu mist will be available for home use. RSV vaccine recommendations have not changed. - F. COH FY27 Workgroup Break Out Meetings and Report Outs
 - a. Behavioral Health: Discussed need to understand County resources, opportunities for partnerships, the definition of mental health vs. behavioral health and root causes. Intersectionality with food & nutrition and physical activity.
 - b. Food & Nutrition: Discussed need to do some asset and resource mapping of County resources, farm to healthcare and research of local agricultural associations. Discussed demographic changes and depletion of minerals in the land.
 - c. Physical Activity: Discussed a "whole-life" approach and ensuring initiatives are innovative and evidence-based. Letter should include impact and consequences, and reversal of chronic conditions.
