- The meeting was called to order by Gail Warner. The March 2018 minutes were approved.
- Introductions were made of SHC members. Gail shared that, unfortunately, Abe couldn't be here due to death in the family.
- Britt Jones Collaboration Council provided a presentation on Vaping, and a handout was provided. The overriding message is that e-cigarettes are not safe.
- Dr. Thandi Hicks Harper Youth Popular Culture Institute provided an overview of the groups work with youth. Their focus is on youth engagement, health, education, and popular culture. Primary focus is on most vulnerable young people. There is a strong emphasis on research and a strong focus on hip-hop culture. Several projects - sip/stupid -underage drinking. Edutainment (merging entertainment with education) - meeting kids where they are. Focus on getting on pulse with young people. How to use hip/hop. Hip/hop has been shown to be effective in suicide and drug prevention. Modules are called CIPHER -free flowing conversation. Make-a-mix is part of the curriculum. Students make their own rap about drug/suicide. Graffiti, Rap, Fashion, Breakdancing are examples. Mantra - If Hip/Hop is used to market product, then how can Hip/Hop used to market prevention.
- DHHS Updates provided by Liz Elliott. This week all nurses to celebrate Nurses week. Celebration scheduled on Wednesday. County government to recognize the importance of nurses.
- SHC subcommittee Reports:
 - Karen Duffy On April 22, MCCPTA held a Mental Health Forum at Gaithersburg HS. . There were many attendees, and a recommendation was made to provide additional forums at various places in the county.
 - Marla Caplon reported that there are more Local School Wellness committees this school year.
