- On-site Certified Housing Counselors will provide rental housing counseling and foreclosure prevention


## **What to Bring?**

*The IRS Does Not Allow VITA to prepare taxes without required documentation.*

- Government issued ID (Valid Driver’s License, Passport, Age of Majority Card)
- **Original Social Security Card or Individual Tax Identification Notice (ITIN)** for each member of your family and last year’s tax return (if available).
- Birth dates for every person claimed on your tax return.
- All W2 forms, forms 1098, 1099, and other documents regarding income.
- All Forms 1095, Health Insurance Statements, or Health Insurance Certificate, if received.
- If filing jointly, your spouse must be present. If filing separately, you must provide your spouse’s social security number and name exactly as it appears on the social security card.
- Statement of annual child care expenses prepared by the provider, with their tax ID (Social Security or EIN number).
- For Direct Deposit: proof of a bank account, including routing numbers. Bank On representatives can assist if you don’t have an account.
